#### VACCINATION PROGRAMS IN THE NEWS: HEARING SET FOR ANTI-VACCINATION MD

From an article by Graeme Hamilton in the July 6 issue of *THE GAZETTE, MONTREAL*, [quoting:]

A renegade doctor who has waged a high-profile campaign against vaccination won her first skirmish with Quebec's College of Physicians yesterday, but the main battle is set for next month. Dr. Guylaine Lanctot, whose 1994 book *The Medical Mafia* topped Quebec best-seller lists for weeks, is accused by the college of breaching the physicians' code of ethics by spreading information that is "inaccurate, deceptive, out of place and contrary to current medical data". [*Sure they're yelping—she's EXPOSING THEM!*]

The complaint accuses Lanctot of making statements in television interviews that could have panicked people and discouraged the vaccination of children. [*Perhaps she was telling the truth!*] Lanctot's statements, cited by the college, include claims that vaccines destroy the immune system, are responsible for the AIDS epidemic in New York and an increase in cancer, and could lead to children being born with mouse tails and rabbit fur. The college also quotes from Lanctot's book, including claims that vaccination aids genocide by allowing people from a certain race to be targeted and that vaccination leads to violence and crime.

If found guilty of the infractions, Lanctot could be barred from practicing medicine.

#### GORE DEFENDS GOVT'S FREE VACCINE PROGRAM

This AP article comes from the June 26 issue of the *ROSWELL DAILY RECORD*, [quoting:]

The nation's poor record in child immunization makes it essential that the government continue offering free vaccines, Vice President Al Gore said Sunday, responding to a report that Republicans hope to kill the program. [*In other words, since some parents apparently choose not to immunize their children, the government should do it for them?*] "Isn't it troubling to see the United States way, way down the list of countries around the world in terms of vaccinating children against diseases?" Gore asked on ABC's *This Week With David Brinkley*. [*It's a lot MORE troubling to learn what's behind this Elite-sponsored vaccine give-away program. CONTACT's January 31, 1995 issue has the story.*]

#### SO DOES LAROUCHE

At least his newspaper, *THE NEW FEDERALIST*, has this to say in the July 10 issue, [quoting:]

The Vaccines for Children (VFC) program, which seeks to guarantee free vaccines to all American children, regardless of income, has come under heavy fire in the Conservative Revolution-run Congress.

The targeting of the federal immunization program for breakup is exactly what Ben Franklin meant when he spoke of “penny wise and pound foolish”.... The federal government’s constitutionally mandated responsibility is to secure the blessings of liberty to this nation—one of the greatest of those blessings being freedom from preventable disease. Let the drug companies—or private doctors—give ‘em away, if they want. CONTACT readers have probably figured out by now that this issue has been totally misrepresented to meet the profit-mongering of the drug companies, as well as the depopulation and total-control agenda of the NWO. So it makes me wonder why LaRouche and his organization are supportive of immunizations.*]

### CRYPTOSPORIDIUM IS NEWS IN CANADA

I hope you read Dr. Young’s astute editorial comments about cryptosporidium and water contamination in last week’s *CONTACT*—these critters are real handy to have around if you’ve a mind to depopulate the planet, due to their capacity to act as a carrier for other diseases. The catchy name—crypto-sporidium—you can almost sing it—has been popping up rather innocuously in the media these last few weeks. This article hales from the July 13 issue of the *VANCOUVER (Canada) SUN*, [quoting:]

The people who safeguard Greater Vancouver’s water supply will decide Friday if they want to spend \$165,000 to study the danger posed by a parasite in the region’s reservoirs. The Greater Vancouver water district’s water committee will vote on a study of the cryptosporidium parasite proposed by the B.C. Centres for Disease Control [*When this group gets into it, it’s time to be suspicious.*] and the University of B.C. When cryptosporidium was discovered in the area’s drinking water last year, medical health officers quickly [*TOO quickly!*] assured the public there was no need to worry.

The study now being proposed would analyze human blood samples from a cross section of the local population to trace the cryptosporidium and determine if it is prevalent enough to cause problems. [*Sounds like they want to check the effectiveness of their cryptosporidium-dispersion program.*]

### TORONTO BLESSING BASHING

This comes from Australia, from a recent issue of *THE COURIER-MAIL*, [quoting:]

Theology graduate Tony Payne, 33, doesn’t look the sort to throw grenades but, as the author of the first major backlash against the so-called Toronto Blessing, in Christian circles that is exactly what he is doing. The Toronto Blessing, in which believers fall down, laugh hysterically or bark like animals while supposedly under the influence of the Holy Spirit has swept churches in the United Kingdom, the United States, Canada and Australia. [*Hmmm, when I was a kid, and got in trouble for behavior like that, it never dawned on me to pass it off as a religious experience!*]

The question of whether the Toronto Blessing is the work of God is causing dissension both in the Pentecostal and mainstream churches. Far from being the work of God, Payne believes the “blessing” is simply a matter of mass hypnosis brought on by the emotional atmosphere and particular dynamics of the meetings where it occurs. His book, *No Laughing Matter: The Toronto Blessing and Real Christianity*, is believed to be the first book published on the subject.

The Toronto Blessing started in January last year at the Airport Vineyard Church in Toronto, Canada. There was an outbreak of odd physical behavior, uncontrollable laughter being a noted feature, which convinced those present that God was giving them a special anointing in preparation for a great worldwide revival. [*Good grief.*] It spread, with an estimated 2000 churches participating in Britain alone.

But Payne believes the phenomena is far from new. “The falling down, the animal noises, laughing, catalepsy—all these manifestations have been seen in Pentecostal and charismatic churches for much of the century,” he said. “These phenomena can also be seen in pagan religions and secular hypnosis.” Far from being a renewal of the traditional churches, Payne believes the followers of the Toronto Blessing are “sincerely deluded”.

For lawyers, the irony of being hoist with their own petard is striking. Lawyers did much to create the litigation frenzy now plaguing them, by convincing people that for every setback, someone is to blame. Now, disgruntled clients are blaming them. Frustrated by high fees, long delays and impersonal relations, they are suing over everything from soured real-estate deals to disappointing trial outcomes, post-trial judgments and appeals—and everyone from solo practitioners to corporate law firms.

Moreover, legal malpractice suits couldn't be proliferating without other lawyers pushing them. With their ranks ever-increasing, lawyers are more willing to sue their own. “You wind up with simple cannibalization,” says Joseph W. ## CHAPTER 2

### THE PIPELINE by Michael Maholy

#### PART XVIII: SIGNED, SEALED, AND DELIVERED

*Editor's note: The last time we presented Michael Maholy's "inside" story about The (C.I.A.) Pipeline was in our 4/25/95 CONTACT on p. 38, where he called that installment: "Setting The Hook". We now join Michael after a 3-month interlude wherein he has been transferred to a new facility, a minimum-security prison, and is now able to again continue with his Pipeline series.*

When we last left off, I was on Norman's Cay, a tiny island in the upper chain of the Bahamas. I was a personal guest of two of the most notorious Colombian drug lords who ever hit the shores of the United States of America: Max Mermelstein, and Rafa Salazar. Along with two other drug pilots, Mickey Monday and Jimmy Cooley, I had embarked upon what started out as a deep-sea fishing trip, but what actually turned out to be another trip into the dark world of drugs, weapons, money and lust—a world in which few have participated.

As it was, we all ended up staying at Carlos Ledher's private island compound, where several hundred tons of cocaine and marijuana would leave for secluded airstrips throughout the U.S. mainland. After a day of diving in the island's lagoon, observing many of the island's underwater residents, I felt that the experience of viewing the many different sizes of the warm water hammerhead shark had climaxed the day. That was purely a false assumption on my part, as the night to follow would bring yet more people to meet, more drugs to ingest, more lust and personal greed.

Although my own ventures into the world of smuggling were increasingly profitable, it still had not been lucrative enough to satisfy someone as ambitious and enterprising as I once thought I was. I was well aware that many of the people I was supplying with drugs and weapons—often men far less talented in the nature of the game—were still making huge profits, more than I was for the efforts put into the business. This is when I first really realized that if I were to become as successful as the people for whom I was working, I would have to begin to think very seriously about getting more involved in the cocaine trade.

To get started, I thought I would have to get in a little closer with the Colombian, Carlos Ledher. But this man was very unpredictable and would go ballistic at a whim. It was that night at a party thrown by the island's host, Carlos, that I would meet a man named Anthony "Butch" Zukas. Zukas was an ex-Navy fighter pilot who was considered a flying ace of great expertise. He had flown down to Norman's Cay in his personal Cessna 210 that had state-of-the-art navigation beacon instruments installed, along with radio scramblers and extra fuel tanks. Max would first introduce me to Zukas, telling me that he and Carlos were very close and that Zukas had made millions in the smuggling trade. Max added that it was a good thing that Barry Seal had left the island earlier, as Seal and Zukas were rivals in the flying game. One was always trying to outdo the other. Carlos was already somewhat mad at Barry Seal for planning the cargo weight of the cocaine that turned out to be too heavy for the DC-10 that had crashed into the ocean earlier
