Whenever something is too horrible for the consciousness, denial is one of the first responses.

The Veterans Association and related organizations officially deny to this very day even the existence of Gulf War Illness, while the death toll rises.

Well, we have reached a crossroads where the American public can make a conscious choice to remain in ignorance if they wish. They can close their eyes, bury their heads in the sand, or just choose to ignore the facts. But the truth about the Gulf War Illness and what has been done to our own loyal American veterans is unforgivable.

What you are about to read in the third part of this ongoing series on the Gulf War Syndrome will infuriate you. The information we are using on this subject is provided by the experts on the subject and from the government's own documents, which makes denial all the more difficult. When people of such undisputed credibility as Dr. Garth Nicolson come forward to speak out about what has taken place against our troops at our government's hand, it becomes very, very difficult to refute. Moreover, when a leading Pentagon official writes a scathing report of America's own complicity and cover-up, it BECOMES ALL BUT IMPOSSIBLE TO DENY ANY LONGER.

The following is a transcription of an interview with Joyce Riley of KENR Radio and founder of the Gulf War Veterans Association [2931 Highland Lakes, Missouri City, TX 77449—(713) 587-5437] and Rick Martin of CONTACT on 8/29/95:

Joyce: I just left Peter Kawaja about three hours ago in Kansas City.

Rick: Oh, really?

Joyce: We just did a huge presentation. They rented a theater, the Inglewood Theater in Kansas City, and they had an excellent presentation. They videotaped it with Peter and I telling the story of the Gulf War Syndrome and on the theater screen we put up all the documented evidence behind everything we say.

Rick: I wish I had known about that.

Joyce: Oh, it was awesome, really good. They've got videos of it, so I can get you one of those.

Rick: Please.

Joyce: People were just in awe. They would gasp. They could not believe what they were hearing. So, it was very impressive.

Rick: Joyce, changing topics here for a minute, I'd like to know as much as possible about George Bush's involvement in all of this.

Joyce: Nancy and Peter will have the most information on that; that is their domain. I met George Bush. I have letters on my wall from him in 1986 and '87 and '88, in which they were congratulating me for what I had done. What happened was, in 1986, I called the White House and invited the vice president [Bush] to come down to Houston and sign an organ donor card. And after making quite a few arrangements the White House said that the vice president said that it would be an excellent idea and he did come to Houston. He told me at the time, "You know, had you been doing this back then or had we had this back when our daughter Robin was alive, it may have saved her life." Well, how many people know that the Bushes had a daughter named Robin?

What I did was, I wrote a letter to the President that I put on my radio program, with *AMERICA THE BEAUTIFUL* in the background, in which I said, "Mr. President, I want you to know who I am. I invited you to Houston to sign an organ donor card, etc. Now, I beseech you to say to the American people, that germ warfare does exist and is killing thousands of Desert Stormers."

And I said, "Do not think that silencing any one of us will silence the story, for we have risked everything to this point to get the story out and we will not stop." I read this on the Houston radio station, with fear and trepidation, I might add. Baylor is here, George Bush is here, James Baker is here, all the players are here.

Rick: You're in a very sensitive spot.

Joyce: Oh, God. And Mr. Barbouti himself, about whom Peter said on my radio program, "I'd like all Desert Stormers to know that Barbouti lives at 2300 River Oaks," which is one of the most expensive houses in Houston. "And I would like everybody to know where he lives so they can go and shake the hand of the man who helped to kill them."

And I didn't know that Peter was going to put that out on my radio show. It was just like, "Oh, my word, give it to him." But it was pretty awesome information.

Rick: Have you learned anything new? Obviously, spending time with Peter—which you've probably done before now, but...

Joyce: This is the fourth visit and each time, of course, we're just jam-packed full of documents and information to share and more material to transfer and learn. It has been very interesting to meet with him and to learn about him. This man is truly one of America's heroes. This man, for five years, scratched and clawed to try and get this message out and no one would listen to him. No one would believe him. And, as I said in my interview with him last night, I wanted to dedicate it to all Desert Stormers who don't even know that he is their hero because he has done for them something that they don't even know about yet. For four years, I didn't even know he was doing it for us. I cannot tell you. This man has lost everything. He went from being a very successful businessman to losing absolutely everything. He has nothing. I had

to loan him \$20 to get home. I mean, it breaks my heart to think that you have such a proud, incredible human being, so successful, and now they've broken him of everything. But he will not give up.

Rick: Where do you stand at the moment? Obviously you've been getting a lot of publicity and you have your own radio show.

Joyce: That's really nothing compared to the Desert Stormers that have been calling. The stories I'm getting from them are what is incredible. The evidence we're getting, the material that is being forwarded to us.

There are some Desert Stormers that you could talk to. There is one guy you might want to talk to who is very interesting because he's on active duty in the Navy and he was marathon qualified. And marathon qualified going into the Navy, he was a tri-athlete. He was an incredibly fit person. He went to Desert Storm and got access to the contagion via the aircraft that came back from bombing the biological sites. When they went into Iraq and bombed those sites, came back and landed on the aircraft carriers, they were not decontaminated. Or if they were, the guys got infected in the decontamination process. I don't know which. But he says that he got it probably from not being protected with the equipment over there. He's very sick now. He can barely walk. He's been in a wheelchair part of the time but he can barely, barely walk. He now is afraid to have children because he knows that all the rest of his veteran friends are having deformed children and he doesn't want to do that. His wife is sick. [*Conversation interrupted by another incoming call.*]

That was a lady calling me who was involved in a mycoplasma experiment in 1970, when the government was first making the crap. She was one of the first people ever to be involved in it and she is really sick now. She's a civilian. She is very sick from this and she has provided me all of her documentation and I mean to tell you, nobody has any idea how bad this stuff is.

But anyway, this one guy I was telling you about who is almost in a wheelchair now, his wife is sick. But she is still working and he is still on active duty, but he can barely work, but they are keeping him on. He's become a sort of threat to them, I guess you could say. The interesting thing, he knew he was contagious with this stuff, so he went to this lady who was in his unit and said, "I need to tell you something. I need to tell you that I have this contagious disease and I know you are pregnant."

And she just went crazy, she went ballistic. She couldn't believe this.

He said, "You know, morally I need to tell you this."

Well, he was brought in for insubordination and told that he is not allowed to talk about the Gulf War Illness. The poor guy. I got a call from him again today, I haven't returned it. But, he keeps me apprised. They're bringing him up on all these charges because he's talking about the Gulf War Illness. Interesting things like that are happening. But it is going to come out. People are getting panicked now. They're starting to get real scared about this thing.

I'm getting letters from guys that are so sick they can't even walk, and they're on five psychiatric drugs.

Other than that, I'm just in contact with these Desert Stormers who are sending me evidence, sending sand, all the things we've been asking for so that we can get it tested. We've had people who have gas masks, gas mask filters that we're going to be able to test—people calling saying they were actually involved with the biologicals and they are willing to sign an affidavit. The more information we are getting out, the more people who are coming forward with information. But so many of those guys who did deal in the biologicals are so sick that all we can do is get them to do an affidavit because they're not going to be around for very long.

Rick: Are you in contact with Drs. Nicolson?

Joyce: Yes, all the time.

Rick: Has pressure increased for them?

Joyce: Yes, there are some things happening there that are pretty stressful but they're just continuing on. They are not stopping. **They are getting over a thousand phone calls a day now.** Isn't that awesome?

Rick: How are they able to handle that in terms of staffing?

Joyce: They had to personally, themselves, hire two people to handle all the phones. MD Anderson [Cancer Center] won't pay for it. They had to hire them and pay for it. They have to pay for the blood tests and everything.

I said to Garth Nicolson the other day, "You know, this financial business is getting to be really rough." That's another thing that bothers me, Rick. Everybody wants us to do this and put our lives on the line, but how can we do this with no money? How can we make all these long-distance calls with Desert Stormers with no money? They want us to put a computer data base together with all these guys and do all the research on all this stuff and there's no money. And people are going to have to understand, the government will not give us a cent to do this. Some money is going to have to come from somewhere. I don't care if it's a benefactor, I don't care if it's somebody who loves veterans. But somebody is going to have to help us out because if we lose out and have to stop this thing because of financial reasons—I'm not working. I'm doing this full time now. There's not going to be anything and nobody is going to be doing it. So, enough said.

I just had a lady on my program whose son just died on August 2, and he died the most horrible, disgusting, painful death you can imagine. And she told the story about it. She said that he was NATO classified and figured that he had such a high security clearance. He was not a paranoid person, he was not a weak person. He was not a weak personality but something happened in Desert Storm and he got something. He came back so sick he couldn't even drive a car. He couldn't do anything. He died a year later but he screamed in pain the whole year before his death, thanks to the V.A. not medicating him. And she said his mouth, the skin was broken on the sides of his mouth where he screamed so much from pain.

This is the most deplorable way to treat our veterans. I am so appalled that this could even happen. She said, "I never doubted my country in my lifetime."

And she said, “Now I know, my son was murdered by my country.”

I talked to one lady who has two deformed children. Her husband is sick. She is sick. Nobody can work. No SSI, no medicare, no medicaid. These people are destitute now, thanks to our country. And America had better get behind these people because they were behind us at one point.

This one guy I was talking to, I said, “You know you’ve got to get angry. Do you know what’s been done to you?”

And, it’s like this kid was 26 years old when he died. It’s so revolting. But this other guy was 25, and I said, “You’ve got to get angry, you’ve got to get motivated. You’ve got to do something.”

And he said, “I’m so sedated by the V.A., I can’t get mad at anything.”

And that is the problem. They’ve medicated them.

We just had another guy who just bled to death from every part of his body. You know, a young guy, 24-years-old, bleed, just hemorrhaged totally.

Rick: How much do you know about Ebola?

Joyce: Only what Peter has taught me, and the fact that it is a long-term disease. It’s a two-year process. The Ebola they used in Desert Storm is a two-year process, as opposed to a two-week process. I don’t have any more specifics than that.

PETER KAWAJA

The following is a transcription of an interview with Peter Kawaja [4338 Sugar Pine Drive, Boca Raton, FL 33487—(407) 241-8407] and CONTACT on 8/30/95:

Peter: You know what happened? Joyce Riley got burned by a laser and they tried to take me out. Did you hear what happened when we went to Kansas City just recently?

Rick: Why don’t you tell me in your own words.

Peter: We were surveilled all three days that we were there. People sitting out in vehicles outside our window at the motel in shirt and ties in vehicles, where they’re sweating, you know they’re sweating. We were followed everywhere. Just threat and intimidation. But it got more serious than that.

As it turned out, when Joyce Riley and I were eating dinner in the evening, she screamed at me to “duck down!” There was a red dot at my head. I went under the table at the restaurant, came back up and as I came back up I said, “No, this can’t be.”

She again screamed out that the dot was a few inches from my head, moving toward my head. And she said, “There it is again.”

Anyway, I dropped to the floor, took some money out of my pocket and we made it out of the restaurant.

We had security there, as a result—the militia and some military people. And we both made it home safely, but she got home and this morning I talked to her. You may want to call her and get this information, but apparently she has a laser burn on her head. [*Joyce Riley did confirm this.*]

So that’s just the last few days.

Rick: Let’s talk about your case. [*Case No. 94-7074-CIV-Moreno, U.S. District Court, Southern District of Florida*] What is the latest development on that?

Peter: Well, the latest development is that I appeared on the 24th. Again, they waited until I went out of town. Let me back up. My case was to be heard on March 10, this year. They filed a Motion to Dismiss based on immunity. They have never responded to my suit. Have you ever seen the charges I’ve brought against these guys?

Rick: No.

Peter: I’ve listed in my complaint three pages of crimes, treason, war crimes, etc. They have never responded saying they deny. They also have never countersued me, never counter-claimed me. Understand?

Rick: Yes.

Peter: All they’ve done is file a Motion to Dismiss, claiming that even if they committed “misconduct”, they should be granted immunity. That’s it.

When they did that, I got an Order from the Judge stating that I have one day to reply to their Motion to Dismiss because they had set a hearing. Now, he didn’t state in the letter I have one day. What they did is—I have the postmark of the letter. After they filed their Motion to Dismiss, they set a hearing for the 10th and he sent me a Notice which I received on March 2, which was a Thursday, telling me I have no later than March 6, which is Monday, to respond. It literally gave me Friday, one day, to prepare the response. Needless to say, I took Saturday and Sunday. Monday morning I walked into court, filed a two-inch thick document, supplied the evidence against these guys. Two days later, Wednesday night, 5:00 P.M., I get a call from the Judge’s secretary stating they have cancelled a hearing because I filed the evidence against them. It was supposed to be heard on Friday the 10th.

Since then, I filed a Motion for Continuance because they cancelled the hearing and the Judge did a Pontius Pilate, when he washed his hands. He sent it over to Magistrate Seltzer for a ruling on their Motion to Dismiss. Dig this. The letter I got from him states that he’s sending over their Motion to Dismiss and their Exhibits, so I filed a Motion saying, “Wow, under the *Constitution*, etc., etc.—Hey, I want you to hear my case. And how could you send over only the Defendant’s Motion to Dismiss and not MY evidence to a magistrate judge to make a decision on whether to dismiss this bloody thing?”

So, they pulled that shit.

Anyway, six months have gone by. They never responded to my Motions for a Continuance, and I've filed about three other Motions. All of a sudden, out of left field, when I went away, the first time in six months, they mailed a letter saying there was going to be a hearing. I came back and I had four or five days notice for the hearing. I filed five motions, shut them down totally, and I filed a Motion for Summary Judgment because, in fact, I have had a little bit of help and some people have looked at the documents—that their Motion to Dismiss, under Rule 12B—they have not filed in sufficient specificity. There are a lot of loopholes; in other words, they've screwed up and they've never refuted my claims. And, in fact, they have admitted to all of my claims and all of the evidence, which means they committed treason and war crimes, etc.

So, I showed up on the 24th and they changed the courtrooms. They thought the militia was going to show up. They locked the doors to the courtroom. They had a bunch of federal agents armed to the teeth with weapons, handi-talkies inside and outside the court—two female federal agents with guns. I brought witnesses with me this time. Linda Thompson thought it was going to be another Joe Love scenario to try to get me riled and drag me away.

We went into the court, and now it's on the record officially. On top of my documents that I filed, it is officially in court record that here the U.S. attorney himself goes on and starts rattling on about terrorists, about IBI, about the PIT plant, about chemical and biological, about the Gulf War, and the judge himself goes, "You've managed to scare and inflame the court." So, it got pretty heavy.

I'll give you a little "sticker" in all of this. Just like the government arrested—do you remember the NSA agent that was arrested outside of the White House who had an appointment with Hillary Clinton? In the meantime they are saying Gulf War Illness is not communicable or doesn't exist. In case they were going to try to drag me away, my only defense when they've built a scenario like that—I took a mask and I wrote right on it "WARNING: GULF WAR ILLNESS—COMMUNICABLE" and strapped it on my arm. When I was in the court I hacked a couple of times, and you ought to have seen all these big, 8-foot zombie, federal agents with walkie-talkies and guns. They moved down into the jury box. I wanted to go over and shake the judge's hand, nobody wanted to come near me. Nobody wanted to come near me. What I did was, because I had filed my Motions for Summary Judgment just the day prior to the court case on the 24th (the hearing) they did not get a chance to look at them and the judge didn't get a chance to rule. What he did was, he did not rule for them or me, he ruled to give the U.S. attorneys 7 days to respond and for him to review my motions, but he is not going to be able to respond. As a matter of fact, they have until tomorrow.

Rick: What is the judge's name?

Peter: The judge in the case, the real judge is Judge Moreno. But he referred it over to Magistrate Seltzer.

What he has done is reserve the decision because he knew it was important, not to mention also that it was on record, and he saw that I brought witnesses and they knew they could not shut it down that very day.

Right now, it's in limbo but they're going to have a serious problem with the documents that I filed. **In fact, they are literally in default and they have admitted to my charges. All they are going on is not**

that it didn't happen, not that they didn't commit any crimes, only that no matter what they did they should have immunity. That's their stand. That's it. That's their only stand because I can prove everything that I've charged them with, so the only thing they can do is fight for immunity. That's where its at.

Rick: As specific as you can be, let's talk about George Bush's direct involvement in all of this.

Peter: George Bush's direct involvement, oh, you don't want me to talk specific because...

Rick: I do.

Peter: I'll be specifically non-specific. In the Kansas City presentation, a lot of people have heard that I have tapes and I may have tapes or I supposedly have tapes of George Bush. I'll make this disclaimer. First, I have tapes. I'm not in possession of any tapes right now, of course...

Rick: Of course.

Peter: I did tape record CIA, FBI, counter-intelligence, members of Congress, lawyers, lobbyists and all kinds of people—calls to and from Bhagdad, London, and all that. But, any specific recordings of Mr. Bush, the President of the United States, you know that it is illegal to really do that and I would not have done that or have had access, although, in fact, I have been told by certain people within the intelligence community a long time ago—I was communicated with through several different means that I have, what's called "friends". In other words, there's about 10 percent of the CIA or 10 percent of the guys on the inside that are, well, they kind of understand; there are really still a few Americans and they don't agree, for whatever reason, with what took place. And, it is very, very, very, very, well, it's possible that somebody on White House staff or somebody at CIA or somebody somewhere may, they may have made a recording—of course, I didn't, and I wouldn't have that access. I don't claim to. If they did send it to me, you can be sure I don't have it. So, I can't be more specific than that.

Rick: I wasn't really asking about evidence but just what you may have knowledge of concerning his involvement with the biologicals or any companies that...

Peter: Oh, definitely with the companies involved in the biologicals and definitely he was seen in the presence of Dr. Barbouti in 1991. Allen Freeman of the *FINANCIAL TIMES OF LONDON*—when I was doing the ABC *NIGHTLINE* joint-venture, they had to feed me stuff as I was feeding them stuff. It was kind of a trade-off. I didn't have a choice, I wanted something done. I now know that they were on a fishing expedition because they got a lot more information from me than they aired. They did a little exposé about Barbouti and if you don't have a copy of that tape I could send you a copy of the *NIGHTLINE* thing. But they did, I think, four different shows, one on cyanide, one on Barbouti, one on illegal—a couple different exposés, not just specifically about me. But it was all about my evidence and Al Freeman wrote the book *SPIDER'S WEB*, but during that time they had to cut loose some stuff. **Even though there is a certificate of death that I, unfortunately don't have a copy with me here, but you could get it—that Dr. Barbouti died again, for the second time, in July 1990. This is the same month that I sent my package to NSA and just before Saddam went into Kuwait. George Bush was seen in the presence, in 1991, from a reliable source of the *FINANCIAL TIMES*, with Dr. Barbouti,**

alive. And, to be very frank, you've got to ask yourself, "Why is the government protecting Haidar Barbouti? He lives in Houston, Texas, 2300 River Oaks Blvd. He married a stripper from *RICK'S CABARET*, so that he could get a green card and pays her, I think, a million dollars a year. I don't have the exact sum, it's a million whether it is every year or every two years. And that is how he has obtained his green card and stays in the United States legally because he is here, as far as I'm concerned, even now, illegally. I don't think she's paying taxes on that million dollars. Know what I mean?

Rick: Yes, I do.

Peter: I have documents from the U.S. Government itself, from the Department of Defense, from the military, from everybody, Customs, everybody, that tag on their own Dr. Barbouti as supplying Libya and Iraq with chemical and biological weapons and that he is a terrorist. I have them on tape that he is a terrorist, but I also have their own documents [stating] that he is a terrorist. Yet, his son heads up 40 corporations in the United States—was approved and bought—[ultimately] didn't end up buying because I proved their scam. But, the FBI approved him. This is why so many agencies are corrupt and you can prove it. I have his application. Not in my home, but I have a full copy of the credit application for him to buy savings & loans—the same type of scumbag with George Bush and Silverado and those other deals. In 1988 he was approved to buy some S&Ls and on his application where it says "job" he has "none", every answer is none. He doesn't own a home, doesn't have a job, doesn't have any source of income, except he has 40 million dollars for the deposit. It is asked, "How do you get the money," or whatever the question is; he puts down, "from gifts and inheritances."

So, my question is, when the FBI is reviewing these applications, if somebody doesn't have any income or doesn't have a backer, how are you going to come up with more money? From gifts and inheritances? Does he kill more relatives to come up with another hundred million? How is it that they approved this guy's application? That's what I want to know.

The agencies have known. Now, they are protecting this guy. He lives in the United States. Their own evidence proves that they know of their own involvement in the PIT plant, in chemicals and biologicals. They know about Prussian Blue. They know everything. And yet, this guy has never, ever, ever been served a search warrant; never been asked to come downtown, with champagne and caviar and a chauffeured limo, just to have a casual chat with the FBI. Nobody has ever questioned this guy. He walks the streets freely. You want to know why he walks the streets freely? Because they acted in accordance and with the United States Government. If nothing ever, forget about any other evidence, if nothing ever proves anything, the government's evidence against these people is that these people are terrorists. And yet, the United States Government is protecting terrorists in America that kill Americans—bottom line.

Rick: What companies is Bush directly associated with concerning...

Peter: I wouldn't want to misquote, but there were about three companies that we listed down there between him, James Baker, and John Deutch. And Brent Scowcroft ain't so clean. Scowcroft is involved in there with them and also has the involvement with a certain entity in the Atlanta area which crosses over

onto a nuclear site.

Rick: If you could provide *CONTACT* with those specific names, that would be very helpful.

Peter: I know. See, a lot of things I know off the top of my head but if you want to know how much information there is, I don't memorize that because of the 40 corporations alone that these guys have, and then that's an octopus to a bunch of others off-shore. And some of them I want to keep quiet because I want these people to hang themselves, like about the death of my wife. I'm going to let them go into court and commit more perjury. The Order to Seal, by the way, for my Affidavit for Search and the search warrant and all of the evidence that was sealed as "national security"—I have a copy of the Motion to Seal and the Order to Seal. On that, it states, "Until the investigation is over." When you now look, in 1994 is when I filed and I got the unsealing. I didn't get the evidence though, I just got to see one of the Affidavits and there's more. What they are saying in their response to me, to my suit is, "there is an on-going investigation." In that document that they filed, their motion, they have now committed perjury because, in fact, there can not be an ongoing investigation because in their original document to seal, it says that it can only be unsealed when their investigation is over. So, they could not have unsealed it because of the names and the information contained therein would have alerted certain potential targets of the investigation.

It goes on and on and my time to prove it is in a court of law and not here. The evidence just goes on and on and on. There are some things that I remember, only because when the action was going down they were significant to me. Now, things are very, very significant; I have the evidence but those things are not memorized or committed to memory, if you get what I mean. The names were too many. The locations were too many. I traveled extensively in Texas and Oklahoma and to all kinds of locations and all kinds of buildings and all kinds of people and I've got pages and pages and pages of names, people, phone numbers, bank accounts, Swiss bank accounts, you name it, and all of the players and George Bush and everyone else connected. But those are not just committed to memory.

One day I will be able to tell you a lot more. But if I tip my hand as I'm talking now, whether I tell it to you on the phone or if I file it as evidence, I have not filed all of my evidence. I have withheld.

But the point is, at this stage, I have to maintain only a certain set of documents that I put out as general, photocopiable, pass-aroundable documents. If what I am doing is not alerting America, nothing will. A signed confession by George Bush himself will not alert America or make them do anything any more. If the evidence coming out by the Nicolsons, by Riley, by myself, by what you are seeing and hearing, even by Hillary Clinton making statements about the medical I.D. card—you are now hearing things that I have written about for a long time. It's coming to pass. If America doesn't react, they won't react for one more piece of paper.

But I will cooperate with you and I appreciate what you're doing and because you are putting it out to the public. As I think of things, or if I go the beach and a bottle washes up on the shore and there's a piece of paper in there that I feel it is time to put out, you'll get it.

Rick: Excellent. Let's talk for a moment about Ebola Reston and Ebola Zaire. I realize the Nicolsons are saying there are anywhere from 10-15 different organisms involved and you have talked about many different organisms and we here at *CONTACT* are very familiar with genetic manipulation and the kind of

experimentation that goes on. We've published a lot about this subject, in fact. Would you talk about Ebola Reston and Ebola Zaire and what you feel is going on?

Peter: What I feel is going on is, well, first of all the Ebola is a man-made warfare weapon. It is not something that evolved out of Africa on its own. It just didn't come into being on its own. I'm trying to be careful not to tip my hand as to what I may or may not have access to other than the fact that I refer to Ebola Reston vs. Ebola Zaire, in that there are different strains of Ebola, where the real Ebola Zaire that everyone knows is the quick-acting killer. In fact, there are other strains of Ebola which are going around and, if I'm not mistaken, I'm starting to hear that there are other outbreaks. But the outbreak that took place in Reston, Ebola Reston is the key, in that there are, as a result of that, proven other strains that are out there that represent Gulf War Illness—are part of Gulf War Illness. And that it takes a lot longer time to manifest itself and to say more than that would maybe give up my source.

Rick: I understand.

Peter: And that is why I refer to it only that way. Most people equate—they say, "Well, the Ebola, you're dead in under two weeks, 9-10 days or whatever it is." Not so, not so. There is a, I call it a different version of the Ebola Zaire. And that is why I use the Ebola Reston version. In layman's terms you've got to explain it and I can't get more technical at this time.

Rick: I was surprised to read the specific horses' names...

Peter: Abe and First Flight?

Rick: Yes.

Peter: Oh, yeah. There's so much more to know about Ft. Detrick and about the immunizations, the Informed Consent Waivers, the new drugs that are on the market today without the clinical trials, stuff like that.

Joshua Lederberg, big time scumbag and his anaerobic cell, and of course, he sat on with Dianna Zuckerman, and Zuckerman now is the one that has a lot of information on me. She is operating out of Hillary Clinton's office directly.

See, these Gulf War babies being born with the one eye to Golden Har [a medical/genetic term indicating a specific deformity] and without the one arm is a specific, specific example of them tampering and playing God. That is Lederberg's basic baby right there, where they can actually make humans, engineer human beings. If you check into the Golden Har Syndrome or to the Gulf War babies being born deformed, it isn't like one of them has one finger missing or an extra finger. It isn't that another one that—well, it isn't an assortment of those deficiencies or deformities; it is consistently specific deformities of eye and arm or limb missing. That is like making human beings. See, they couldn't make human beings with three or four arms. Any nurse working on that would start thinking aliens have landed. If you can engineer somebody to come out without specific arms and limbs, you can make them grow parts of their body in the way you want them to grow. I have certain other specific information, but that's off the top of my head

about Joshua Lederberg and I believe he was awarded the Nobel Prize in 1988 for his work.

But that is where they are going with this anaerobic cell thing and the super-soldier that I was referring to. And you get a good drift of that, in layman's terms, when you look at the movie with Jean Claude Van Damme, *UNIVERSAL SOLDIER*.

Rick: What is the next stage? What should we be looking for in terms of the illnesses? Are there going to be any surprises coming up? How do you feel efforts are best put forth at this time?

Peter: Well, it depends. There will be other illnesses coming up—like really, the Ebola is going to come to be a more common outbreak here. The TB, Staph and Strep, all those are part of it. Really, it depends how they are reacting to not just me, but you guys putting out our information.

Again, I see things that are coming out by the first lady, and I'm being kind, making statements. But what I see they are doing is that they are pushing up targeted dates to a Medical I.D. Card and it seems like they are almost—something is going to have to give on that. But this skirmish with Iraq is definitely a provoked attack on the part of the U.S. We're not just finding out all this new stuff about Saddam having SCUDS with chemicals and biologicals in it; that's a crock of shit. That's what that is. We're getting these things and they keep insulting your intelligence, telling you that Saddam is trying, on the one hand, to win brownie points by coming clean, only that he's an asshole. Excuse my language because I'm really mad.

Rick: No, that's fine.

Peter: He's coming forward with this voluntary information after telling us no. They want you to believe that he's saying this in order to make brownie points, which will insure that they don't give him brownie points, that they continue sanctions. How stupid do they really think the America public is? It is just stupid. But I guess a lot of them are because they're believing it.

I am so mad at mainstream media and how America could swallow that crock when they're putting it out. I can't believe that.

Rick: How is your response on the talk shows? Obviously you're getting the word out verbally.

Peter: Really, really great. When I do a show now, I try to get people to ask questions. Some people are calling up not only with questions, but it is telling me that there is a portion of America that is really informed. On one of calls that I did this morning, he came right out and nailed it on the head and said the Gulf War was planned in advance and he started rattling off documents and things that happened to show that we actually instigated that war with Iraq for an agenda other than what America was told. So, it's good to see that. And people are asking intelligent questions. Finally, they are very concerned.

One of the guys who called me up, he only heard part of a broadcast that I gave your number, to get *CONTACT*, and he said, "I hear all these terrible things but is it contagious?" Oh, man. When I told it to him he said, "Oh, my God, what's their number?" He wants more information. [*CONTACT*—800-800-

5565]

But it's unbelievable. Mainstream America needs to hear it. The show Joyce Riley and I did in Kansas—they put us on for a half-hour gig and at the end of the half-hour they got so many calls, when we hung up the phone they pre-empted another show and did another half hour show because so many people were screaming and yelling for information. People out there are hungry but, what it is, they just don't know. A lot of people know there is a problem with America, there's a problem with the government and they have all kinds of beefs and different things, but they really don't know how bad this is and what it really means. And I think if you could only get the word out to the majority of mainstream America who do not read, necessarily, your publication. That's the sad part. They'll turn the boob-tube on; you can't reach them. I wish we could because that's what it's going to take. It's not going to take just a few people.

Rick: Are you finding that you're getting the support? Obviously you've been stripped bare financially.

Peter: No, I have no support monetarily. I had somebody give me \$5 and I'm sending them some literature. I didn't ask for it, they mailed it to me. At Kansas City they took up a collection, but I took four or five days out of the work I'm trying to do. But, I got \$150 for that. I didn't ask, they took a voluntary collection but I have no financial assistance and I've been fighting the IRS, the California Federal Bank and this case for five years on my own. And so, no one. I wrote to Gerry Spence and sent him a package. He bowed out and sent me a nice letter how he thinks I have a great cause and he wishes he could help. I wrote to the "dream team" through F. Lee Bailey's law firm and they sent me a nice letter, bowing out. There was an attorney and I shouldn't mention his name; he said, "Your case is wonderful. You've got 'em." I showed him some stuff; he said, "At the minimum what I want to do is ghost write for you because I want these guys." He has this nice office. Within 24-hours, the guy called me back. I received a Federal Express package, all my documents back—of course he probably photocopied them, but what I sent him wasn't my complete case. Just enough for him to know what it was about. I think he made a phone call. He bowed out and never did what he said he was going to do, including ghost write. But he did say to me—he shook my hand and said, "I can't withstand another IRS audit."

It may be, he may have taken on a few questionable clients, I don't know.

The only attorney I talked to who also had some involvement in Iran/Contra basically wanted \$300,000 to fight the government and he said, "It's \$300 grand to fight 'em, and if you win, you lose."

Back in 1990, the government offered to hide me before they tried to kill me. Back in '90 what they did was immediately offer me to go into the Witness Protection Program and on the phone they made me an offer so I would shut up, that the government would support me for the rest of my life. I would not have to work another day, ever.

Rick: I'm sure they would love that.

Peter: You go into the Witness Protection Program, you say good-bye to your friends and family, nobody knows where you are, you change your name. You go down to Acapulco and you think you're doing real good. One day you're laying on the beach sipping a Tia Maria with your blonde "membrella"—and you die as a John Doe. Well, my mamma didn't raise no fool.

Rick: *[Laughter.]*

Peter: So I turned them down, naturally, and they got pissed. And that is when they told me that I was a walking dead man. From that day, his words have rung true. They certainly have tried.

I don't publicize the death threats anymore. I've tried to stop this from being a "Poor Peter" deal. I want people to get behind this for the atrocity against these Gulf War Veterans and Americans. I don't want them to get the impression that I'm crying for me, because they're going to get me one day. What are you going to do? What am I going to do? You tell me.

Rick: Stay conscious. Stay alert.

Peter: That's it.

Rick: And frankly, the only protection that I am really aware of is prayer and asking God to protect you.

Peter: Yes, that's what I do because I figure most of it is threat. Not all of them. If they really, really, really wanted me dead, I am not that good and I have no real protection here. I do go out to restaurants from time to time or travel on the road, and I know that. I know that it is by the grace of God and the fact that this must be something He wants to take place. And as the Nicolsons have said, some of these factions have refused to kill because they themselves have been sick and some of them, even though they are murderers-for-hire, are still Americans. And a lot of people are finding out that the real agenda involved in this—see, the real agenda with this wasn't just a war with Iraq. The real agenda has to do with the New World Order. Even the mafia that may control gambling or this or that, or whatever they do—I'm not going to start getting myself into more trouble—but whatever it is, a lot of these people are Americans. They're not into this New World Order stuff, you know?

Rick: They're not into mass depopulation. For one thing, it cuts into profits.

Peter: Yeah, so not everybody is sick and satanic like these people are. So there are different reasons. It's very hard to do this. I know I have to. I've been approached to do a book and I have refrained from putting out a video or a book for a long time. And I have not charged for even the literature I've mailed out or the cost of reproductions, for the years and years and years that I've fought this. But I've slowly gone broke, and I realize that I can't just keep doing it. If I want to get the word out, I have to somehow do something. But it is amazing, as many people as I think would know by now, I have not received either a benefactor or someone who even has their own (even if it's a personal) axe to grind—that it would further their cause or a common cause. There is no greater cause today than the Gulf War and the killing of veterans and all Americans. There is no question as to what is taking place. I cannot believe—you know, there are a lot of people out there who are billionaires who are just not into, necessarily, New World Order; they're just rich folks with yachts and living a lavish lifestyle and would like to continue living a lavish lifestyle. Maybe they just don't know what is really going on. I really don't know. But I'm really surprised that some attorney doesn't take up the cause or somebody doesn't do something to fight it.

I'm not looking for a handout. And I'm not looking for somebody to send me the cash. I'm looking for—let's prosecute the case and let the chips fall where they may. Let's get this information public. Let's do a

video. Let's do a TV program. Let's do something. Let's let America, let's show them what they need to see. Let's put on TV the TRUTH for the first time in a hundred years. Let's put the truth on there and then we'll see. I'm not looking for somebody to send me ten bucks. It's sad; it's not that way. But I fight the fight and, you know, my car is busted down and I patch it up to keep on. I take a licking, but I keep on ticking. Whether somebody sends me a penny or not, I've done this on my own and I'll continue to do it because the cause is just and there is no other. Other than that, we might as well just lay down and die because where they are going is exactly there. There is nothing more to live for if we don't stand up now.

Rick: I understand the Drs. Nicolson are having to hire additional staff out of their own pocket at the MD Anderson Cancer Center, just to answer calls on the Gulf War Illness.

Peter: Yes. It creates a burden. As you see, my phones have slowed down because I stopped answering them. Luckily, I have the ability through somebody else to get another line but people call up and ask for literature. There are some people who volunteer to pay my photocopy costs, but it is a burden to live and you can't do this and hold a job. Where do you go to work? They've destroyed my security career. Published in the security magazines today are people who call themselves Americans but who have no idea what that word really means and they're starting to—you know, they did some write-ups in the security magazines about the Oklahoma bombing and about patriots. Can you see me as the security director of some major corporation? They consider me, now, because I'm outspoken about the government and about crimes, a security risk. They have effectively not only shut my business down, threatened all my employees, taken my money, but basically destroyed my 30-year security career in that there is no place for me to go. So, generating an income is very, very hard. I get little drips and drabs here and there in fighting the case.

What I really want is for people to understand what my suit is and what the truth means to them because I don't think we've got—maybe two years. I don't really now even predict a time frame. I see so much moving—the events moving so fast. The massive shut-down campaign and disinformation campaign in the media and what the president and the first lady are doing and the supposed U.N. I'll tell you what. After the 1996 elections, I think all hell is going to break loose. I think that is the only thing they are waiting for. But they are moving the agenda up fast. I'm very concerned.

I wish all of this was just me. The whole point is, it isn't a story of one man. It isn't the story that I made this up. This is stuff that actually exists. All this stuff really happened. It really, really happened. And it is happening before your eyes. The timing is right. They've got the technology. And they have no choice. America is bankrupt. And the New World Order is coming to your door. It's coming. They're going to bring it to you. And if people don't stop it now, we will have no more *Constitution* and we will have no more America, and they don't understand how drastic that is. And people, every day, are just going about their business and/or not becoming involved. And they just don't realize how very, very serious it is.

You know, Canada has gotten real bad. They can't distribute literature about the New World Order there. They'll be arrested. It's gotten very bad.

From the reports of the Gulf War veterans that I'm getting and people dealing with the V.A. and the military and the things that are happening out there when you put it all together, it's insurmountable as to what is in store for us and the fact that, man, we will have no freedom in this country. It will be just tyranny. Terrible.

I'm beside myself and yet I can't do any more. I'm on the verge of being sick every day. Every time I think my health is getting better—it bothers me to no end. I don't get sleep. I don't get rest. I have no life. I can't go to the beach and I live in Florida. I don't ever feel safe. How do you ever go on? And for five years I have been trying to tell people to get involved and do something. This isn't about helping me. This is not about Peter. I am a vehicle and I am a straw on the camel's back and I can break 'em. I can break 'em because I can prove it in a court of law and I can break these guys. This is the one issue here. This is a war crime. These are crimes against the Geneva Convention. We can stop the New World Order if people get behind what we are doing, collectively behind the Nicolson, Riley and myself. I think that's what needs to be done. What more can I do? I have no resources other than people like you. That's about it, man.

Rick: You know that *CONTACT* will do its part.

Peter: Well, I appreciate that. Thank you for it and all America will thank you for it. It is just happening. I don't like to dwell on it because it is almost where you have to—I **understand why Americans, normally, regular people—they don't want to face it because—I'll tell you what, it is so hard to understand that you have to make such a drastic change in the way you think and what you plan for the future. Because I'll tell you what; there is no future. You either go along every day today, day-by-day and ignore it and think you have a future or, if you really just looked at the evidence in front of you and opened your eyes, it is such a hard thing to deal with. It really is. It is hard to accept what's happening and what is really taking place. I understand.** It's hard for me. It's a bummer and it brings you down and the only saving thing for me, every day I keep going is from people like you. I get a call from a person or a veteran who thanks me. Or somebody who calls up and says, "Thank you for what you are doing."

And I remember my wife. I talk to her or I see the blood in the carpet and, every day I remember and I will never forget what they did to me and what they did to her. I will never forget what they are doing to Gulf War veterans. And it is beyond me and it has to be satanic that the government of America, the DOD and the V.A. can say what they say and I can prove it. They know what they are saying. They are out there just outright lying to America but they have no choice. They can never admit what they've done. I really don't know where this is going to go. I just don't know the outcome. I just don't know what to expect.

Rick: Can you explain—I know it is sensitive for you—what exactly they did to your wife?

Peter: What they did to my wife is a form of an Ebola. It is a very disgusting—it is meant to tear you apart as you watch the person dying in front of your eyes. So it is not something that I would want to go into, but it is something where you bleed everywhere and you die.

I have the evidence of what I need and I have what she left behind and I have whatever else I need that I shouldn't say on the phone. My day will come to take it before the people. My day will come.

DRS. GARTH & NANCY NICOLSON

The following is a transcription of an interview with Dr. Garth Nicolson and Dr. Nancy Nicolson and CONTACT on 8/30/95. Garth L. Nicolson, Ph.D., is the David Bruton Jr. Chair in Cancer Research and Professor and Chairman of the Department of Tumor Biology, The University of Texas, M.D. Anderson Cancer Center, Houston, Texas 77030. (713) 792-7481. He is also a Professor of Internal Medicine and a Professor of Pathology and Laboratory Medicine at The University of Texas Medical School at Houston. He has published over 400 scientific and medical papers and

edited 13 books, and he is the editor or associate editor of 12 scientific and medical journals.

Nancy Nicolson, Ph.D., is the President of the Rhodon Foundation for Biomedical Research, Kingwood, Texas 77339. She has published over 20 scientific and medical papers.

Rick: You mentioned before we went on tape that there were some errors in the statements made by Joyce Riley that you wanted to correct.

Garth: The first thing, we did not physically isolate the mycoplasma. What we did is, we probed for DNA sequences on the mycoplasma. They're in the mycoplasma; that's how we follow it. We have not actually isolated the mycoplasma. What we've done is, we've probed for the specific genes of the mycoplasma. So, that's one thing we wanted to correct.

Rick: Now, Joyce mentioned that you are receiving quite a number of calls.

Garth: Yes, we're actually receiving thousands of calls on this, sometimes per day.

Rick: How are you handling that?

Garth: We've had to hire somebody full time to do nothing but handle the telephone and the mailing.

Rick: And what about treatment?

Garth: Well, we don't treat anybody. What we do is suggest to primary care physicians suitable treatments on the basis of what we find in terms of the blood workups. We, generally, get a sample of blood from the veteran or their family member and then we examine the white blood cells of the blood for the presence of invasive micro-organisms. And we are particularly interested in finding these types of mycoplasmas. And those mycoplasmas, we know, are behind much of the Chronic Fatigue Syndrome that is caused by the Gulf War Illness.

Rick: What kind of reception are you finding within the medical community itself? I don't imagine there is a great deal of awareness among physicians around the country about this, is there?

Garth: Oh, it's gotten much better, actually. In fact, we have some real experts who are working with us now, such as Dr. Herbert DuPont, who is Head of Infectious Diseases at Baylor College of Medicine in Houston. In fact, he is a co-investigator on a recent grant.

Nancy: Just a couple of things that I wanted to add. Garth told you that it is not isolating the mycoplasma, nobody has successfully isolated it, once it is in there.

Rick: I will make that correction.

Nancy: And also, when calling, Blake is handling the calls concerning Desert Storm. The other important thing to mention is that our hospital administration has been put under severe pressure by the CIA and the Defense Department to halt this research. But Dr. LeMaistre let us do the pilot study and, even upon

retaliation of loss of critical specimen funding, he let us do the study and there has been a turnabout.

Rick: What kind of turnabout?

Nancy: The point was, he was under so much pressure because on top of the Defense Department and CIA, former President George Bush is on our Board of Visitors. But he still let us do the pilot study under extreme duress. I know that he understands the issue, germ warfare. But he still stood up and let it go on and he has given his blessing to the program.

One other thing I wanted to tell you. The Jewish community, in an article called “The Lie In The Sand” by Goldenberg, went out in all the Jewish papers worldwide, where it actually states and explains that SCUD missiles did have germ warfare materials when they exploded over Saudi. And it explains the logistics behind it and, in the end, he slams the Pentagon as lying. So, Israel is beginning to tell the truth. So that’s important because this just came out on Thursday.

Did Garth tell you how we—in our pilot study of the soldiers we’ve looked at—now this is not a controlled study. We just—the people who came to us whose families were sick—that’s what we’re concentrating on—the contagion. 35% are positive for *mycoplasma incognitus*. But, 55% overall were positive for a mycoplasma infection.

Rick: How many people in this study?

Nancy: Right now we’re over a hundred. These statistics will probably change somewhat as we accrue more information but we still don’t know what the other 45% have. We can only speculate on at least some of the other organisms being *Brucellosis* and *Anthrax*.

Garth: I presented a document to the President’s Panel on Gulf War Syndrome. Did you get a copy of that?

Rick: No, I did not.

Garth: That’s actually a 30-page document...

Nancy: It actually shows the scientific data, what it looks like.

Garth: I’ve actually put some data in there.

Nancy: And we also have a paper in press in *THE JOURNAL OF OCCUPATIONAL AND ENVIRONMENTAL MEDICINE* which shows the overlap of symptomatology between the Desert Storm Illness and Chronic Fatigue Syndrome.

Garth: I can send you a preprint of that.

Nancy: We’ll also send you a copy of Lindsey Arison’s report on the Gulf War cover-up. He gave me permission to say this. He is the Chief Financial Analyst for the Air Force in the Pentagon and he slams the Pentagon.

Garth: You should get a copy of this because it is a hot item. It comes right from a top person in the Pentagon [*document quoted later in this article*].

Nancy: And it explains everything we've been saying. You have to understand that these biologicals were designed; Garth calls them "stealth". They are very difficult to detect. Garth did present, at the Veterans Affairs and Pentagon in Washington and they tried everything to break the science but they couldn't. The Air Force's Institute of Pathology could not detect the mycoplasma because they weren't going deep within the cell nucleoli.

Garth: And they were using antibody-base tests, which are not reliable for this.

Nancy: So, it's really amazing to us.

Garth: A lot more will become clear to you if I send you this document. Then you can ask us some specific questions.

Nancy: I have to tell you that I have been in a great deal of communication with Israel. I told Israel that they had to come forward spiritually, that if they didn't, it is a turning point in human civilization. The chief rabbis didn't really understand that you can't defend against biological warfare without having an offensive. They didn't understand that once you release a biological, it doesn't matter if it's released over Saudi, it is going to get into Israel. It is not containable. They understand it now. Some of the best scientists have been eliminated, over a two decade period, who would not go along with this. So they see the light and I'm happy.

The work we've done with the mycoplasma is going to be translated and spread over all of Russia and all of Israel and all the Middle East. So, that's a good sign. And the people I am in communication with...

Garth: One of the important things is that we have been in communication, essentially through a Palestinian network...

Nancy: Also, we've worked with the Iraqis...

Garth: And they've told us—for example—one Palestinian has talked to practically every health ministry in the Middle East and 25% of the entire population of Kuwait appears to be sick with Gulf War Illness. And about 20% of Saudi. And about 20% of Jordan.

Rick: Of the entire population?

Nancy: Yes.

Garth: Of the entire population.

Nancy: In Iraq, of course we had an emissary; you can't verify these figures. He said there were approximately 250,000 dead in southern Iraq.

Garth: And 1 million people sick.

Nancy: Sick. We can't verify this.

Garth: We have no way to verify the Iraqi count.

Nancy: Israel told me, I knew they would admit, they are having a problem but they are a little more swift and they have been taking care of their people.

There has been a global gag order.

Garth: This is actually a much bigger story. You could keep doing this for a while.

Nancy: I mean, it's awful.

In an article provided to *CONTACT* by Drs. Garth and Nancy Nicolson, and written for *THE AMERICAN LEGION* by the Nicolsons, titled "Chronic Fatigue Illness and Desert Storm," they write, [quoting:]

Staff Sgt. George Vaughn served in an Army military intelligence unit in Desert Storm and came upon an unusual event while traversing the Iraqi desert. He saw thousands of dead sheep by the road and stopped to investigate. There was no outward manifestation indicative of the causal agent of the sheep's death, until he got a closer look. What he saw shocked him. The only thing he noticed that was wrong was that the sheep's nostrils were red and swollen. But when he looked closer, he noticed that even the insects on the sheep were all dead. Unfortunately, Sgt. Vaughn did not have on his NBC (*nuclear/biological/chemical*) protective suit at the time and was probably exposed to agents that have now rendered him incapacitated and unable to report to active duty since Desert Storm.

When Sgt. Vaughn returned from the Gulf War to his new post at Fort Meade, MD, he had Gulf War Illness. Along with Chronic Fatigue Syndrome, Sgt. Vaughn also had Multiple Chemical Sensitivity (MCS) Syndrome, has been sick to this day, and has been trying unsuccessfully to get help. Now Sgt. Vaughn's wife is becoming sick, but without MCS. Sgt. Vaughn and his wife have not been able to get treatment for their symptoms at military hospitals, including the Army's Walter Reed Medical Center in Washington, D.C.

Army Capt. Charles Hamden returned from the Gulf War after service with the 101st Airborne Division (Air Assault) out of Fort Campbell, NY. He was deployed on the deep insertions into Iraq. His unit did not come under enemy fire, and he considered his service relatively uneventful, until approximately six months after he returned to Fort Meade, MD in 1991. What started out as a relative benign series of flu-like illnesses became progressively worse with coughing, nausea, gastrointestinal problems, skin rashes, joint pain, memory loss, vision problems and severe headaches. Then Capt. Hamden's wife began to have chronic fatigue and gynecological problems, aching joints, headaches, and her stomach began to swell, causing severe pain, until she looked 9 months pregnant. Even his 7-year old daughter became ill with similar flu-like symptoms that did not go away and progressively became worse, resulting in chronic fatigue, skin lesions, vomiting, headaches, aching joints, and inability to gain weight. While this was happening, Capt. Hamden and his family were under the care of Kimbrough Army Hospital at Fort Meade and Walter Reed Medical Center. They never received a diagnosis, explanation or treatment of their illnesses, even after extensive testing. Later they found out that several families of Gulf War veterans at Fort Meade

had similar health problems and nowhere to go for help. These families were being told that they had psychological problems, but they claim—and can prove with documentation—that they are sick and deserve proper treatment.

Maj. Pete Zalewski was an Air Force Special Operations intelligence officer attached to the 5th Special Forces Group based at King Fahd Airport west of Dhahran and the 160th Special Operations Aviation Regiment at King Khalid Military City. He was involved in the Special Forces operations deep in Iraq. After his return to the U.S., he noticed that he had a constant sore throat, night sweats, shortness of breath, dizziness, joint pain, short term memory loss, vision problems, diarrhea and other bowel problems, skin rashes and severe to moderate fatigue. He eventually left the military and has not been able to obtain treatment from VA hospitals for his illness.

Another Special Forces officer now in the Delta Force at Fort Bragg was a Navy Lt. Cmdr. in charge of a SEAL unit that was involved in some of the most sensitive covert missions during Operation Desert Storm. He presented after the Gulf War with chronic fatigue, fever, stomach cramps, joint pain, skin rashes, memory loss, dehydration, headaches, heart pain and other symptoms. His vision became so diminished that physicians at Womack Army Hospital were considering surgery. He stated to us that he had “every conceivable test conducted, treatments, etc., known to the military with zero results, zero answers and zero relief.”

Although most military, VA, and civilian doctors agree that these Gulf War veterans have medical problems, they have been unable to diagnose the exact syndrome. Even worse, some military and VA physicians don't even believe that Gulf War Illness exists, and they do almost nothing to treat the illness. [End quoting.]

Later in the article, [quoting:]

The medical problems experienced by many Desert Storm veterans, and in some cases their families, is one of the ongoing mysteries of the Gulf War. In an attempt to answer criticisms that the DoD and VA were not taking these problems seriously, Gulf War Registration Units and Desert Storm Referral Centers were established by the Dept. of Veterans' Affairs to document health complaints. Next, a Technology Assessment Workshop was organized by the National Institutes of Health (NIH) with the task of examining information and reports on Gulf War Illnesses, recommending working case definitions for these illnesses, developing plausible etiologies and biological explanations for the illnesses, and finally recommending future research efforts to understand, diagnose and treat the illnesses. In fact, some of the aforementioned tasks, such as the establishment of initial workshops and Referral Centers at VA hospitals, have been accomplished.

Unfortunately, the lack of any concrete results and, for the most part, the lack of significant progress in assigning diagnoses and initiating effective treatments for veterans and their families for their Gulf War illnesses have not received appropriate priority, even with the political pressure of the American Legion

and other veterans organizations. Also, the politicians in Washington do not seem to be very interested in this issue. **Even worse have been the categoric statements of some officials, such as DoD Undersecretary John Deutch [now head of the CIA] that there was no use of chemical or biological weapons during Desert Storm, effectively eliminating these important sources of the illnesses from careful consideration by military and VA hospitals.**

In 1994 a national panel was convened to discuss the medical problems of Gulf War veterans. The NIH Technology Assessment Panel issued a Workshop Report on Desert Storm Illnesses that was meant to address fears that these illnesses were not being taken seriously and to establish practical working case definitions for the chronic illnesses associated with Operation Desert Storm.

Unfortunately, the Workshop Report issued by the Technology Assessment Panel did little to address the Gulf War veterans and their families' charges that next to nothing was being done to help them. Earlier this year the Institute of Medicine (IOM) of the National Academy of Sciences criticized the government's efforts as "intrinsically unsuitable for systematic study of the health efforts of the Gulf War." While several departments (DoD, Veterans Affairs, Health and Human Services) are arguing over appropriate clinical studies and better coordination, tens of thousands of Gulf War veterans remain chronically ill without much help for their plight.

Even worse, there has been essentially no attempt to enlist medical and scientific specialists to help in this problem. In addition, there has not been any appropriation of funds to conduct proper research into the possible causes or potential treatments of Gulf War Illnesses.

In their frustration, Gulf War veterans representing all 50 states met March 10-12, 1995 at a Unity Conference ("Four years after the Storm") of Gulf War veterans organizations in Dallas under the direction of Air Force Maj. Denise Nichols (a retired nurse) to exchange, discuss and disseminate information on patient registration, medical and employment assistance, legislation, and medical/scientific issues of importance to Gulf War veterans. One of us (G.L.N.) was asked to chair the Medical Panel where environmental, chemical and biological sources of Gulf War Illnesses were considered. Indeed, an important conclusion of this panel—which was similar to other panels—was that there appeared to be no single cause or source for the collection of illnesses called Gulf War Illness or Desert Storm Syndrome. Patients seem to fall into several categories, some with only MCS, some with chronic fatigue syndrome without MCS.

One of the first things that the panel did was dismiss a psychological origin of Gulf War Illnesses. Not that psychological problems did not exist among the soldiers of Desert Storm, but after careful assessment of the symptoms of the overwhelming majority of Gulf War veterans, the symptoms did not fit with a psychological origin of the diseases.

A member of the panel in Dallas, Dr. William Rea of the Environmental Health Institute in Dallas, has been treating Desert Storm veterans for MCS. This condition can be the result of environmental exposure to chemicals in the air or by direct contact or the use of chemical weapons. Many units reported the use of chemical weapons in Desert Storm. Most of these reports have been abruptly dismissed by the DoD, but the authors of this article find it difficult to dismiss the rather large number of these reports, and most importantly, the number of individual testimonies that indicate that many soldiers had immediate, classic symptoms of chemical attacks while the NBC alarms were sounding. In a previous article on Gulf War Illnesses in the January 1995 issue of *THE AMERICAN LEGION MAGAZINE* the issue of the use of chemical weapons in Operation Desert Storm was discussed. The author concluded that the use of

chemical weapons by Iraqi forces cannot be dismissed.

Some soldiers were exposed to chronic environmental conditions during Desert Shield and Desert Storm that can produce some chronic conditions such as coughing and pneumonitis. Another member of the panel, Dr. Andras Korenyi-Both, was the Commanding Officer of the Army's 316th Station Hospital in Desert Storm and has been examining the inhalation of very small sand particles that produce what he has called *Al Eskan Disease*, a pneumonitis that causes flu-like symptoms and eventually immunodepression that can result in opportunistic infections.

Environmental stress and infections can result in the activation of endogenous human viruses. Dr. Howard Urnovitz of the Calypte Biomedical Corporation in Berkeley discussed his findings that up to 85% of veterans (and their families) with Gulf War Illness have antibodies to certain human viruses in their urine. These viruses are human endogenous retroviruses (HERVs), and they are associated with a variety of autoimmune disorders.

Many of the symptoms of Gulf War Illness can be reproduced by infectious diseases. Dr. Edward Hyman of New Orleans has been examining Desert Storm veterans for the presence of bacteria in their urine and has found that many Gulf War veterans have evidence of bacterial infections. He has successfully treated many of these veterans and their families with broad spectrum antibiotics. The U.S. Senate Banking Committee has documented the transfer of dangerous bacteria (such as *Anthrax*, *Brucellosis*, *Botulinum* and other disease-causing bacterial strains) from U.S. companies to the Iraqi Atomic Energy Commission well before Desert Storm—and these were only the *unclassified* biological agents that were sent from the U.S. with Commerce Department blessings to Iraq. [End quoting.]

Later in the same article by Drs. Nicolson, [quoting:]

In our preliminary study on a small number of Gulf War veterans and their families we have found evidence of mycoplasmic infections in about one-half of the patients whose blood we have examined. Not every Gulf War veteran had the same type of mycoplasma DNA sequences that came from mycoplasmas bound to or inside their white blood cells. Of particular importance, however, was our detection of highly unusual DNA sequences in the same samples by the same technique. These highly unusual DNA sequences included a portion of the HIV-1 (the AIDS-causing virus) genetic code, the HIV-1 *envelope* gene, but not the entire HIV-1 viral genome. Thus these soldiers were not infected with the HIV-1 virus, because the virus cannot replicate with only the HIV-1 *envelope* gene that we detected. Interestingly, the specific DNA sequence that we detected encodes a protein that is expressed on the surface of the mycoplasma and would enable any mycoplasma to bind to many cell types in the body, and even enter those cells. Thus this genetic manipulation could render a relatively benign mycoplasma much more invasive and pathogenic and capable of attacking many organ and tissue systems in the body.

We are now working with Dr. Urnovitz to ascertain whether the HER viruses were also used to modify some mycoplasmas. Such findings suggest that the mycoplasmas that we have found in Gulf War veterans are not naturally occurring organisms, or to be more specific, they were probably genetically modified or “engineered” to be more invasive and pathogenic or quite simply, more potent biological weapons. [End quoting.]

In a report titled “*Mycoplasma Infections in Gulf War Illnesses—Results of a Preliminary Study on the*

Prevalence of Mycoplasmal Infections in Desert Storm Veterans with Chronic Fatigue and other Symptoms,” presented to the President’s Panel on Gulf War Syndrome in Washington, D.C. on August 14-16, 1995, Drs. Garth and Nancy Nicolson write, [quoting:]

A variety of health problems of returning U.S. and coalition forces from Operation Desert Storm/Desert Shield have been reported. Among the over 600,000 U.S. military participants in Operation Desert Storm (ODS), approximately 50,000 have registered with VA and DoD with health problems. These include a collection of symptoms characterized by disabling fatigue, intermittent fever, arthralgia, myalgia, impairments in short-term memory, headaches, skin rashes and a collection of additional symptoms that has defied a careful case definition. This disorder has been called Persian Gulf War Syndrome (GWS) or Desert Storm Illness. It has been agreed that many Gulf War veterans do have medical problems, but it has also been argued that the symptoms of GWS are not well established as criteria for particular illnesses and they do not readily fit into common diagnosis categories. This has resulted in unknown diagnoses, or worse, they have been diagnosed with psychological problems, such as Post Traumatic Stress Disorder (PTSD). The military personnel that we have interviewed were particularly disdainful of this explanation for GWS.

Frequent problems reported are gastroenteritis, colitis, dermatitis, and other symptoms not associated with traditional diagnostic categories or specific ICD-9-coded diagnoses. Many of the cases included nonspecific symptoms of chronic fatigue, skin rashes, muscle and joint pain, headaches, memory loss, shortness of breath, gastrointestinal and respiratory symptoms, and other symptoms that do not readily fit into a common case diagnosis. In the absence of a clear and complete diagnosis and effective treatment of symptoms for many ODS veterans, the concept of a distinct syndrome peculiar to the Persian Gulf Theater of Operations (GWS or Desert Storm Illness) has been advanced, although it has not been proven.

Medical explanations for GWS have remained elusive. Parasites such as *Leishmaniasis* and bacteria such as *Cholera* are endemic in the Middle East and could be the cause for symptoms in at least some of the soldiers with GWS; however, diagnostic tests are available for many of these agents, and there have been no reports that they are the causes for symptoms in a large number of patients with GWS. In some cases the explanation has been attributed to known parasitic diseases, such as infections by *Leishmania tropica*, probably spread by the sandfly *Phlebotomus papatasi*. This can result in viscerotropic leishmaniasis. However, many of the common symptoms of GWS do not fit with this explanation, and diagnosis of leishmaniasis is uncommon in Gulf War veterans. Nonetheless, it is unclear how prevalent leishmaniasis infections are in GWS patients.

The variable incubation time of GWS, ranging from months to years after presumed exposure, the cyclic nature of the relapsing fevers and the other symptoms are consistent with a disease caused by biological agent(s). [End quoting.]

In his report dated July 14, 1995, titled *The “Cover-Up” of Gulf War Syndrome—A Question of National Integrity*, Dr. Arison writes, [quoting:]

FACTS

1. Before the Gulf War, Iraq had a highly developed chemical warfare program with numerous production facilities, stockpiled agents and weapons, binary [*utilizing two harmless ingredients that upon combining form a lethal substance*] (precursor chemical/solvent) capabilities, multiple and varied delivery systems, and a documented history of chemical warfare agent use.

A month before the war began, then CIA Director William Woolsey estimated that Iraq possessed 1,000 tons of poisonous chemical agents, much of it capable of being loaded into two types of missiles: the FROG (Free Rocket Over Ground) and the SCUD B (SS-1).

On July 30, 1991, Ambassador Rolf Ekcus, Director of the United Nations Special Commission on Iraq (the organization charged with overseeing the elimination of Iraq's chemical and nuclear arsenals), told the Security Council that U.N. inspectors found chemical warheads armed with nerve gas and that some warheads were already fitted onto SCUD missiles.

Chemical warfare munitions and agents which either survived the allied bombings or were inventoried and returned to the Muthanna facility for destruction included:

- * 13,000 155-mm artillery shells loaded with mustard gas (H),
- * 6,200 rockets loaded with nerve agent,
- * 800 nerve agent aerial bombs,
- * 28 SCUD warheads loaded with nerve agent Sarin (GB),
- * 75 tons of nerve agent Sarin (GB),
- * 60-70 tons of nerve agent Tabun (GA), and
- * 250 tons of mustard gas and stocks of thiodiglycol, a precursor for mustard gas.

U.N. inspectors concluded the Muthanna plant was capable of producing two tons of Sarin (GB) and five tons of mustard gas (H) daily.

There is substantial evidence to suggest that in the use of chemical weapons, the Iraqi military adhered to, at least in part, Soviet military doctrine. Soviet military doctrine suggested that chemical warfare should be conducted with mixed agents. Mixed agents, often referred to as “cocktails” are intended to enhance the capabilities of nerve agents and defeat the precautions taken by the enemy. Cocktails can be made by combining a wide variety of biotoxins [*a poisonous substance (toxin) produced by or found in a living organism*], nerve agents, vesicants [*an agent that induces blistering*], and some biological agents—such as bacteria and fungi.

Iraq may have also acquired any one of a number of the Soviet binary “Novichok” series of ultra-lethal

toxins that, even in microdoses, can be debilitating. In addition to inducing myosis, vomiting, memory loss, involuntary motions, and internal organ dysfunction, these toxins can have mutagenic [*mutation: a relatively permanent change in hereditary material involving either a physical change in chromosome relations or a biochemical change in the condons that make up genes*], effects and have no known antidotes.

2. Iraq also had an offensive biological weapons program with multiple research and production facilities, evidence of weaponization experimentation, and a history of reported use.

According to the United Nations Special Commission on Iraq, the Iraqi biological warfare program was initiated in mid-1986. U.N. inspectors specifically uncovered evidence the government of Iraq was conducting research on pathogen [*a specific causative agent (as a bacterium or virus) of disease*] enhancement on biological warfare-related materials to include:

- * clostridium botulinum (the cause of botulism),

Iraq admitted to making and storing nearly 5,300 gallons of the bacterium, theoretically enough to kill 15 billion people. Inhalation of one microgram (or about as much as would fit on a pinhead) is enough to cause death by paralysis within hours.

- * bacillus anthracis (the causative agent of anthrax),

Iraq said it made about 158 gallons of the anthrax bacteria in concentrated form, an amount U.N. officials say is enough to be packed inside 40 to 50 bombs that could each kill tens of thousands of people. The organism multiplies within the body after inhalation and kills within a day or so by halting breathing.

- * clostridium perfringens (the most common causative agent of gas gangrene),

- * clostridium tetani (the causative organism of tetanus or lockjaw),

- * brucella abortis [causes brucellosis or undulant fever (fever marked by alternating periods of abatement and increase of symptoms, pain and swelling in the joints, and weakness) and is contracted by contact with infected domestic animals or consumption of their products; also the cause of contagious abortion in cattle and other domestic animals],

- * brucella melitensis [causes brucellosis or undulant fever (fever marked by alternating periods of abatement and increase of symptoms, pain and swelling in the joints, and weakness) and is contracted by contact with infected domestic animals or consumption of their products; also the cause of brucellosis in goats], and

- * franciscella tularensis (causes tularemia; transmitted to man by the bite of an infected tick or other bloodsucking insect, by direct contact with infected animals, by eating inadequately cooked meat, or by drinking water that contains the organism. Symptoms may appear from 1 to 10 days after infection and include headache, chilliness, vomiting, aching pains, fever, sweating, loss of weight, and debility.)

In addition, U.N. inspectors revealed that biological warfare-related stimulant research was being conducted on:

- * bacillus subtilis (causes conjunctivitis),
- * bacillus megatillus, and
- * bacillus cereus (an opportunistic invader of immunocompromised [*The condition of not having a normal immune system. This may be due to a genetic or disease process or to drugs administered for the purpose of inhibiting or inactivating the immune system.*] patients).

This suggests that the Iraqi government may have been experimenting with e.coli [*Escherichia coli*] and recombinant DNA (rDNA) [*DNA prepared in the laboratory by breaking up and splicing together DNA from several different species of organisms.*] to create genetically altered microorganisms (novel [*new and not resembling something formerly known or used*] biological warfare agents).

Novel biological warfare agents, created by altering DNA plasmids [*An extrachromosomal ring of DNA that replicates autonomously in bacteria.*] and vectors [*An organism that transmits a pathogen.*], are specifically intended to avoid detection. **Several shipments of biological materials that may have been used to carry out such a program were licensed for export from the United States to the Iraq Atomic Energy Commission.** In such a program, common intestinal flora such as e.coli could be altered to produce viral, bacterial, or other toxins, and would be difficult to treat. **If Iraq was successful in developing such agents, diagnosis will continue to elude physicians testing for traditional illnesses.**

3. We, the United States, provided the government of Iraq with “dual use” licensed materials to develop their chemical and biological programs.

These materials included chemical warfare agent production facility plans and technical drawings (provided as “pesticide production facility” plans), chemical warhead filling equipment, chemical warfare agent precursors, and biological warfare-related materials.

4. U.S. chemical protection equipment was ineffective.

It has been fully documented by the National Security and International Affairs Division (NSIAD) of the General Accounting Office, U.S. Congress and by independent Senate investigation, that U.S. soldiers were not adequately equipped to conduct chemical operations during Desert Storm and are not adequately equipped now. (*Chemical Warfare: Soldiers Inadequately Equipped and Trained to Conduct Chemical Operations, GAO/NSIAD-91-197, May 1991*).

5. U.S. chemical detection alarms were ineffective.

The principal chemical agent detection alarm used during the war, the M8A1, was not sufficiently sensitive to detect sustained low levels of chemical agent and to monitor personnel for contamination.

Further, U.S. Army Material Safety Data Sheets indicate that chronic exposures to levels of over one-tenthousandth of a milligram per cubic meter (.0001 mg/m³) to nerve agent Sarin (GB) is hazardous and requires the use of protective equipment. The minimum level of chemical agent required to activate the automatic chemical agent detection alarm M8A1, commonly in use during the war, exceeds this threshold by a factor of 1000. Despite the fact that M8A1 alarms do not detect blister agents such as mustard gas, during the “air war” alarms were sounding so frequently, many were simply turned off.

6. The United States did not have any biological agent detection capability whatsoever during the Gulf War.

7. After the air war started in January 16, 1991, coalition forces were chronically exposed to low (non-lethal) levels of chemical and biological agents released primarily by direct Iraqi attack via missiles, rockets, artillery, or aircraft munitions and by fallout from allied bombings of Iraqi chemical warfare munitions facilities.

- * Chemical detection units from the Czech Republic confirmed chemical agents,
- * French detection units detected chemical agents,
- * Chemical specialists from the British Army detected chemical agents,
- * Both Czech and French forces reported detections immediately to U.S. forces,
- * U.S. forces detected, confirmed, and reported chemical agents, and
- * U.S. soldiers were awarded medals for detecting chemical agents.

In considering the consequences of the placement of troops in areas downwind (where non-lethal exposure to chemical warfare agents might be expected), it must be remembered that chemical nerve agents, such as Sarin (GB) and Soman (GD), have CUMULATIVE effects. After a single exposure, daily exposure to concentrations of a nerve agent insufficient to produce symptoms may result in the onset of symptoms after several days. Continued daily exposure may be followed by increasingly severe effects.

8. During the November 10, 1993 unclassified briefing for members of the U.S. Senate, in response to direct questioning, then Under Secretary of Defense, and now Director of Central Intelligence, (Chemical Engineer and Physical Chemist) Dr. John M. Deutch said that the Department of Defense was withholding classified information on the exposure of U.S. forces to biological materials during the Gulf War.

9. The Department of Defense continues to publicly claim, however: “There were NO confirmed detections of ANY chemical or biological agents at ANY time during the ENTIRE conflict.”

This is the sworn statement of Mr. Edwin Dorn, Under Secretary of Defense for Personnel and Readiness, to the Senate Banking Committee on May 25, 1994—a statement in direct contravention with what then

Under Secretary of Defense Dr. John M. Deutch told U.S. Senators on November 10, 1993.

In a letter to all Persian Gulf War veterans (dated coincidentally the same day as the Senate hearing, May 25, 1994), General John M. Shalikashvili (Chairman of the Joint Chiefs of Staff) and William J. Perry (Secretary of Defense) also directly contradicted what then Under Secretary of Defense Dr. John M. Deutch told U.S. Senators on November 10, 1993. Both affirm:

“There is NO information, classified or unclassified, that indicates that chemical or biological weapons were used in the Persian Gulf.”

10. There are now over 50,000 veterans suffering from Gulf War Syndrome [Remember that these are the cases as reported to the V.A. However, I ask you to keep in mind Joyce Riley’s figure of approximately 200,000 currently infected. This figure also includes family members.], including some 11,000 still on active duty. There are also over 3,500 British veterans with the syndrome.

11. Over 2,200 Gulf War veterans have died in V.A. hospitals [Again, remember Joyce Riley’s figure of 7,000 dead. There will always be discrepancies with any “official” count. Those readers who have been with CONTACT for some time will recall the widely divergent and rapidly changing/adjusted numbers of casualties during the Gulf War.] This does not include any who have died in civilian hospitals.

12. In many cases, Gulf War Syndrome appears to be transmissible—unlike Agent Orange [An herbicide widely used as a defoliant in the Vietnam War that contains dioxin as a contaminant. Agent Orange accounted for over 60% of the total herbicides disseminated over Vietnam (11.7 million gallons of a total 19.4 million gallons)], which was not passed on to family members by the veteran.

In addition to the 50,000 [reported] veterans who are sick, there are thousands of spouses, parents, and children who are also suffering from the same debilitating illnesses—and in the case of a disproportionate number of newborns, birth defects and physical abnormalities.

CONCLUSIONS

Gulf War Syndrome is the direct health consequence of prolonged (chronic) exposure to low (non-lethal) levels of chemical and biological agents released primarily by direct Iraqi attack via missiles, rockets, artillery, or aircraft munitions and by fallout from allied bombings of Iraqi chemical warfare munitions facilities during the 38-day air war.

The effects of these exposures were exacerbated by the deleterious and synergistic side-effects of unproven pyridostigmine bromide pills (nerve agent pre-treatment pills which were administered involuntarily), the investigational botulinum toxoid vaccines (which were also involuntary), anthrax vaccines, depleted uranium residues principally from battlefield vehicles damaged by depleted uranium-tipped armor-penetrating munitions, and to a much lesser extent, other environmental hazards such as oil fire contamination, pesticides, petrochemicals, and electromag-

netic radiation from radars and communications equipment.

The infinite number of combinations and permutations of the effects of chronic exposure to low, non-lethal levels of cumulatively-affecting chemical nerve agents, to blister agents, biological agents and “cocktails”, coupled with the effects of nerve agent pills, botulinum and anthrax vaccines, depleted uranium dusts, and other environmental contaminants, has produced the infinite variations in symptomatology in Gulf War veterans. Therefore, the “mystery illness”. There is, however, one principle cause.

The Department of Defense, however, continues to deny that chemical and biological agents were used during the Gulf War.

REASONS FOR THE COVER-UP OF “GULF WAR SYNDROME”

1. Official acknowledgment of Iraqi use of chemical and biological agents during the campaign would have created panic among coalition forces (the basic purpose and precisely the desired effect of chemical warfare). We chose not to acknowledge.
2. The cost of providing appropriate medical care to all afflicted veterans and (because of the syndrome’s apparent transmissibility, in many cases), to their families, would be prohibitive. It would be impossible to determine exactly where the government’s liability ends.
3. Exposing the fact that our chemical suits and chemical detection alarms are ineffective would reveal a critical military readiness problem. DoD did not want Iraq (then) and does not want any potential adversaries now (such as North Korea which is also both chemically and biologically capable) to know just how gravely vulnerable we are. Notwithstanding this very perilous risk, U.S. troops were deployed to the Gulf.
4. Admission would seriously erode soldiers’ trust in their leadership. If soldiers learn that their leaders will deliberately send them into battle with worthless protection against chemical and biological warfare and then turn their backs on them as soon as the fight’s over, there will be no one willing to fight—especially when they know that whatever biological agents they’re exposed to will, because of their communicability, injure their loved ones as well, once home.
5. There is increasing concern that before the Gulf War, the U.S. secretly provided Iraq with chemical weapons AND the technology and materials to manufacture their own—to use against Iran. A Marine Corps EOD (explosive ordnance disposal) specialist discovered and photographed chemical munitions with U.S. markings and lot numbers in an Iraqi bunker. (Note: Five United Nations reports have confirmed the use of chemical warfare agents in the Iran-Iraq War.)
6. There is also concern that we, the United States, the principal signatory to the Chemical Weapons Convention (CWC), had chemical weapons in the Gulf and used them.

In his January 28, 1991 interview with Saddam Hussein, CNN’s Peter Arnett asked specifically about chemical weapons. (Note that many attacks and confirmed detections made by Czech, French, British,

and U.S. forces occurred before this interview. The air war started on January 16, 1991.) This is the text verbatim from the CIA translation:

[Arnett:] *Will you use chemical weapons in a land war in Kuwait?*

[Saddam:] *We will use weapons that match those used by our enemy against us. I believe that you have had experience with us now. I believe that you have now found out that we have done everything we have said.*

[Arnett:] *The multinational forces said they will not use chemical weapons against you. Does that mean if they do not use them, you do not use them?*

[Saddam:] *I said: We will use the weapons that are equivalent to the weapons used against us.*

U.S. Army graves registration specialists, who are now critically ill, have confided they were exposed to contaminated Iraqi remains in mass burials. And, the Iraqi government, in July 1995, while admitting the long-denied existence of their biological weapons program, claimed U.S. use of chemical agents during the Gulf War.

Official acknowledgement of U.S. use of chemical weapons would completely derail the Chemical Weapons Convention and destroy our national honor and credibility.

7. Admission could threaten the Middle East peace process. At 5 A.M., January 18, 1991, Iraq attacked Israel with nerve gas. Israeli police confirmed the nerve agent, at least three Israeli citizens were killed in the attack, and Marine Corps General R.I. Neal (now Deputy Commander-in-Chief, U.S. Central Command) authenticated this fact in a military log which is now a public document.

Official announcement in the Israeli media of the fact that Iraq attacked Israel with nerve gas during the Gulf War would have escalated the war and could damage the peace process even now. It is believed by many that the billions of dollars the U.S. paid to Israel immediately after the war was the “deal” struck to keep them from retaliating and to cover up the attack.

8. DoD’s failure to permit soldiers to refuse the unapproved, experimental, and investigational botulinum toxoid vaccine during Desert Shield/Desert Storm is a criminal violation of the Nuremberg Code. Did not any of the Hippocratically-sworn military physicians administering the unapproved vaccine find it unethical? “Following orders” is no excuse for unethical conduct, even in combat. And how can the United States be the self-proclaimed global champion of human rights if it is so willing to conduct “research” on competent adults without their informed consent?

9. Admission now would cause embarrassment for the Bush Presidency. At the time of the attacks, the decision to deny the occurrence of (and in effect cover up) Iraqi use of chemical and biological weapons, would have to be made by the National Command Authorities (The President and the Secretary of Defense, Richard B. Cheney).

Moreover, in his letter to President Saddam Hussein of Iraq on January 5, 1991, President Bush wrote:

“...the United States will not tolerate the use of chemical or biological weapons. You will be held directly responsible for terrorist actions against any member of the coalition. The American people would demand the strongest possible response. You and your country will pay a terrible price if you order unconscionable acts of this sort.”

Official acknowledgement of Iraqi use of chemical and biological agents during the campaign would have ignited public outrage and “forced” the United States to follow through. The National Command Authorities obviously decided not to put us in the situation where we had to do what was threatened. In other words: No need to follow through on a threat if the attack is unacknowledged.

10. Admission now would cause serious embarrassment for General (retired) Colin L. Powell—a potential political candidate in 1996. If the National Command Authorities did, in fact, “order” General Powell to deny the occurrence of the Iraqi attacks, why didn’t he stand up for his soldiers? He knew of their vulnerability. This could be a very serious question of personal integrity and loyalty.

BOTTOM LINE

DoD is lying to our veterans and their families, to the U.S. Congress, and to the American people about the exposure of U.S. soldiers to chemical and biological agents during the Gulf War.

“Our afflicted veterans are sick and suffering, and many have died. Others are now destitute, having spent tens of thousands of dollars, depleting their life savings, in an unsuccessful search for an explanation for their ailments. The veterans of the Gulf War have asked us for nothing more than the assistance they have earned. Our refusal to come to their immediate assistance can only lead others to question the integrity of the nation they serve.”—Senator Donald W. Riegle (D-MI)

Why was Thatcher in your country for weeks prior to this massive manipulation and transfer of your troops to the Middle East? It is high time to remind those, who through ignorance or stupidity support the bankers' meddling in every country of the world, that the republic of the U.S. was founded on two basic principles:

Government is the SERVANT OF THE PEOPLE; and, THE REPUBLIC WILL STAY CLEAR OF ANY FOREIGN MEDDLING AND ENTANGLEMENTS. Therefore, you can only deduce that it is for special interests that the government acts against your best interests and sends your children off to insure the theft and robbery of your world for the international bankers and the benefit of the Bolshevik/Zionists who plan to control your world by force and enslavement, completely, by no later than the year 2000. The PLAN is ahead of schedule, my dear friends, and a nuclear war is a major part of the PLAN.

It was for the principles of the Government as Servant and the intentions to stay out of foreign meddling which the Founding Fathers risked their own lives in the creation of your republic. Although this was a novel idea at the time, your Founding Fathers lived up to their principles. Upon securing independence, they did not go about trying to wipe out every presumed bad guy from the face of the Earth.

When the British Establishment railroaded America into its initial war against Germany (World War I), it had, in fact, reasserted its position as colonial master of North America. American blood and money was spent solely for the purposes of bailing out London's aggression against Germany and world colonialism from certain defeat.

The British Establishment had engineered World War I for the dual purpose of weakening its European rivals, France and Germany, through a mutual bloodbath and consolidating its predation of the Middle East and its colonialism in the rest of the world.

Needless to say, the British Establishment's institutionalized piracy was never of any benefit to its own English citizens and even less to American citizens: It strictly served the international bankers. Interestingly enough, the best and most brilliant record of British manipulations at that time was done by Gen. Leon Degrelle, a nationalist Belgian general who volunteered to fight the Communists in W.W.II and escaped Allied "justice" by seeking asylum in Spain in 1945. It is labeled *Hitler: Born At Versailles*. IT CAN BE OBTAINED FOR \$26.95 FROM LIBERTY LIBRARY, 300 INDEPENDENCE AVE. S.E., WASHINGTON, D.C. 20003. I SIMPLY CANNOT ASK THIS SCRIBE TO DO ALL OF YOUR HOMEWORK IN ORDER THAT YOU COME INTO YOUR OWN CONFIRMATION—NOR CAN THESE ONES FINANCIALLY AFFORD TO SUPPLY ALL OF YOU WITH COMPREHENSIVE INFORMATION. I AM *NOT* GOING TO REWRITE ALL THAT IS ALREADY WRITTEN, AS CONFIRMATION OF OUR TRUTH, UPON YOUR PLANET.

Thus, America's involvement in World War I had nothing to do with defending America or carrying the torch of freedom; it had ALL to do with squandering American lives and money to bail out the British Establishment. One of the most nefarious British predations, apart from the colonization of the hard-working Boers of South Africa, was its conquest of the Middle East, and specifically Iraq.

And you want to know about microbiological and chemical warfare and your participation vs. that of any other nation? Read *A Higher Form Of Killing: The Secret Story Of Chemical And Biological Warfare*, Robert Harris and Jeremy Paxman. PROMISES AND MORE PROMISES

The Arabs—that includes the Iraqis—had been promised by the British freedom from Turkish domination if they would join in the British side in the war. Promises of huge amounts of money were also made. Land promises (such as Palestine) were made to the Arabian Peninsula tribal chiefs for their joining the British war. American intervention having tipped the balance, the British proceeded to renege on all their promises to everybody:

The Italians did not get Greece, Greece did not get Turkey, and the Arabs got neither freedom nor Palestine; the moribund Turkish rule was replaced by ruthless British colonization and Palestine was quickly given to the Israelis.

Thus, far from striking a blow for freedom, American intervention has enslaved half of the most civilized people in Europe into the hands of hate-filled thugs and the people of the Middle East exchanged one colonial master for another. The pattern was now well established: America and all its resources would from then on be subordinated to the interests of the London-based international bankers.

British propaganda has, to this very day, managed to cover up its railroading of America with generous doses of appeals to “save democracy”. The bankers’ control of the media has made this task most easy indeed. You are just told and shown exactly that which “they” desire you to believe.

BUT WHY IRAQ?

World War I concluded in 1918 with International Finance the clear and only victor over the pile of 20 million bodies. Bolshevism had been financed to enslave Russia, Zionism had been given Palestine, which belonged to the Palestinians and America was co-opted to perform any dirty work required by the master bankers anywhere in the world. British broken promises and subsequent colonization did, however, stir a reawakening of the long-slumbering Arab world.

The Arabs had lived off past glories for centuries and resented being colonized by the pompous British, particularly when untold oil wealth was being discovered under their lands.

For years the British exploited the oil and kept the natives quiet through the creation of kings, sheiks, sultans, emirs and princes who acted as British puppets in the exploitation of the land and its people. In case the British could not quite manage, America could always be counted on to lend the necessary hand and money to the deal. The powerful tribal Bedouin chieftain Ibn Saud was suddenly declared king of the entire Arabian Peninsula by the British.

BRITISH WHIMS

The bazaar merchant Al Sabah in the Iraqi town of Kuwait was likewise made the emir of the region and SEPARATED FROM IRAQ! Countries were cut off, boundaries rearranged, populations shifted, sheikdoms and emirates created to the whims of the British and international bankers. The whole Middle East and its resources were kept in banking hands with the British policy of “Divide and Rule” and with the help of local traitors who exist in every country for a good price.

The bankers thought they could defuse Arab national aspirations by officially decolonizing the Middle East and running it through puppet kings and the like. In Iran the CIA, at British behest, overthrew the populist Dr. Mohammed Mossadegh and imposed a tyrannical emperor or shah on the country; and in Iraq the British imposed a king. Things started to unravel when the puppet king was overthrown by nationalist Iraqis.

The British, however, managed to stop Iraq from reclaiming its lost territory of Kuwait in 1961.

THUS THE OVERTHROWER WAS OVERTHROWN

Failure to recover Kuwait was, in fact, one of the reasons used by Saddam Hussein when he participated in the overthrow of President Kassem, the man who had overthrown the British puppet king. Kassem was succeeded by well-meaning, but ineffectual President Abdul Salam Aref, who was killed in a helicopter accident in 1966. He was succeeded by his brother, Abdul Rahman Arif, who was deposed in 1967 by Saddam Hussein and his Baath Party.

Saddam Hussein's strength was based in the closely knit tribe of the Takritis—an all important factor ignored by the State Department pundits. The entire Middle East is run along tribal lines, and an intricate alliance system which has proven totally incomprehensible to your so-called Middle East experts. Tribal survival in the Middle East as elsewhere is not for the faint-hearted: It is a live-or-die process with winner-take-all outcome.

Thus, Saddam Hussein had survived and won in an environment no Westerner could fathom, let alone sustain. Many names have been levelled at Saddam Hussein when he was suddenly transformed by the media from Mr. President Hussein to the "Butcher of Baghdad". Hussein's record is well documented but is not better or worse than any other Middle East ruler and certainly a lot less hypocritical and totally forthright in intent.

It is ironic but not surprising that Saddam was courted and rewarded by both the West and the Soviets *as long as he made war with the Iranians who had kicked out the bankers and Zionist puppet, the shah. FOR TEN YEARS SADDAM RECEIVED GOOD PRESS AND BILLIONS IN AID, ARMS AND CREDIT—FROM YOU!*

After returning to Iran, the Ayatollah Khomeini had extended the hand of friendship to Iraq and offered to join forces with Iraq and the rest of the Islamic world to liberate Palestine from Zionist occupation, a basic policy of Iraq's successive governments since the fall of King Hussein (no relative to Saddam or Jordan's ruler of the same name—"King" is simply a label, not a title).

Instead, Saddam chose to invade Iran on the advice of Mossad operatives who managed to convince the Iraqis that Khomeini was dying with only two months to live and Iran was near collapse. That was in 1980. Instead, Iranians proved to be no pushovers, and a punishing and bloody war of attrition ensued for eight long years. Try reading *Iraq-Iran War*, which is a Middle Eastern point of view of the fratricidal conflict. \$9.95 from Liberty Library. After a million men on both sides lost their lives, the war ground to a halt through the sheer exhaustion of the parties.

The Iranians failed to topple Saddam and Saddam failed to topple the Mullahs. However, since Iran suffered the most casualties, Saddam was perceived as the winner. But the win had its poison pill, namely the billions Saddam had to borrow to sustain the war. When it became obvious that Iraq was unable or unwilling to repay the loans, the bankers decided it was time for a gas hike so that Iraq's war debts could be paid by American and European gas consumers: a tax disguised as a gas hike.

Once again the ordinary citizens of the West were picking up the tab to bail out shaky banks and make big

oil even richer. A villain was needed and Saddam conveniently obliged to change from the West's golden boy to a new "Hitler" and this term is brandished about in every media presentation, or mis-representation as the case is. All the hysteria, posturing and histrionics are so much desert sand thrown into the eyes of the shaken-down public.

There is no oil crisis except the ones manufactured by the banks and big oil and Western and Communist governments eager to distract attention to a new bogeyman from the growing wrath of their respective citizens. The fact remains that the world, with or without Iraqi and Kuwaiti oil, is floating on a sea of oil which has glutted the market for years and will continue to do so unless an artificial oil crisis, as in the 1970's, is manufactured.

Thus the "crisis" is a bonanza for big oil and the international bankers but a disaster for the common folk. If people wake up to the massive scam the Bush Administration can be counted on to launch a Panama-type operation against Iraq, which could turn out to be another Vietnam. This would also be greatly welcomed by the Establishment as just the right type of war to pull the country out of the recession created by the gas hike—and golly, those war projects and war supplies companies belonging to the Cartel will flourish once again. THE ENFORCEMENT IS ALREADY ALONG THE NEW CONSTITUTION WHICH IS INTEGRATED, ALREADY, INTO THE UNITED NATIONS' CHARTER. DO YOU NOT ALREADY HEAR THE PROPOSAL TO REPLACE THE AMERICAN FLAG BY THE UNITED NATION'S FLAG ON THE U.S. SHIPS IN THE PERSIAN GULF? WELL, ISRAEL IS NOT YET READY FOR THAT MANEUVER BUT IT IS ALREADY IN PRACTICE WHETHER OR NOT THE FLAG HAS BEEN CHANGED, DEAR BLIND MICE.

Defense contractors were facing the end of a gravy train filled to the brim with public moneys because of the collapse of the Cold War with your "ALLY", Russia. Meanwhile, American politicians were struggling with public opinion polls showing massive public disapproval of their performances and Israel was confronting the dual crises of unpopular mass immigrations from the Soviet Union coupled with the unrest among the subject Palestinians.

With his lightning strike into tiny, near defenseless Kuwait—and at the request of the "original" Kuwaitis, Iraqi Saddam Hussein brought a smile to the faces of the just-mentioned afflicted parties although, of course, they could not express their delight publicly. Instead, the Establishment media has, since August 2, been filled with vitriolic condemnation of Hussein and dire warnings that he must be brought to heel through the application of American military might.

TURNAROUND

This was a direct turnaround since the Western media had for years been portraying Hussein as a good guy despite his vicious rule—Hussein's internal security police are the most ruthless and disciplined in your world.

Hussein's government emerged at the end of the eight-year Iraq-Iran War in 1988, with billions of dollars in war debt, as we have already covered, and his main revenue producer, his vast oil reserve—second only to Saudi Arabia—was not producing the income he had to have because of the intentionally depressed worldwide oil prices.

Kuwait had backed Iraq during the war with Iran and lent it billions of dollars, but therein lies the truth of it—the “puppet” Kuwaiti dancers had buried the actual Kuwait government of the people.

Kuwait always had been part of Iraq, providing it with a port in the Persian Gulf, which in fact, WAS AN IRAQI PORT. In 1959, after the British terminated the status of Kuwait as a protectorate, Iraq moved in immediately and made Kuwait part of its territory, since it was a constituent part of Iraq, known as Basra, at the time of the country’s formation in 1925. However, the British quickly returned with troops and Kuwait remained “pronounced” independent. There was certainly no invasion of the “People of Kuwait” but rather a reaffirmation of unity against the puppet British government.

The action took the world by surprise, allegedly, and the United Nations, President George Bush, Western Europe and even some Arab states reacted with cries of outrage and calls for international sanctions. Funny thing, it absolutely and totally coincided with the close of Congress allowing for everything militarily to be handled by Executive Order, a lengthy, many meetinged visit by Thatcher and myriads of secret government planning sessions in total seclusion from the “people”. (Read the *Journals* and *Expresses*.) Actually, no-one other than “you the people” were in the least surprised for the maneuver and manipulations were planned to the last tiny detail and, once again, the U.S. taxpayer is the BIG SUCKER to bear the bill and the brunt.

Funny thing happened on the way to these meetings: Hussein had massed troops on Iraq’s border with Kuwait for many weeks, invited foreign military attaches to observe his troops’ maneuvers and had issued ultimatum after ultimatum to Kuwait to join with him, forgive the war debt and provide billions more in revenues derived from oil pumped out of disputed wells that straddle their common borders. The puppet British/Zionist government in Kuwait was ordered not to budge—by the Cartel Elite and international bankers.

Even so, there were no demands from the U.S. for action against old buddy, Hussein. In fact, Bush had threatened to veto a congressional proposal shortly before the “invasion” to cut off \$400 million in agricultural credits that were to be extended to Iraq.

Now good old Hussein is being depicted as some sort of a monster by the Western media, which is for the first time detailing many stories about him which were brought forth about the man, himself, years ago. These accounts are only now being brought forth because wider publicity serves the purpose of the international Elite that anonymously dictate events from their offices in New York, Zurich, London and Tel Aviv.

American politicians will be able to distract the people from outrage at their shortcomings, the international banks will gear up to provide loans to BOTH SIDES in a likely coming war, the military-industrial complex will have renewed reason to exist, Big Oil will profit enormously from the run-up in petroleum prices, Japan will be brought into line by control of oil, AND ISRAEL WILL BE ABLE TO STEP OUT OF THE SPOTLIGHT THAT HAS BEEN FOCUSED ON ITS GENOCIDAL REPRESSION OF THE PALESTINIANS, ALLOWING IT TO REDOUBLE ITS EFFORTS WITHOUT “PESKY” INTERFERENCE FROM THE OUTSIDE—WHILE THE U.S. CONTINUES TO FOOT THE BILL BUT WITHOUT THE DISTRACTION OF AN IRRITATED TAXPAYING PUBLIC.

LET US CONSIDER

HISTORICAL TRUTH

Saddam Hussein was the darling of the Establishment for many years. He represented the great hope for the defeat of radical Islamic movements in the Middle East, personified by the Iranian regime of Ayatollah Ruhollah Khomeini and his successors. Fundamentalist Moslems are, by Israel's own definition, "a threat to its interests".

Throughout the period of the long and bloody Persian Gulf war, only a few told you, the American people, the truth about Hussein and his murderous regime. It was the Iraqis, of course, with whom the U.S. sided in the recently defused Iran-Iraq War.

"The Iraqis attacked Iran and caused the war *at the instigation of Israel and the U.S. along with England*, despite a general acknowledgment that Iraqi leader Saddam Hussein was noted as a person who was not very nice.

Although Hussein's rule was no less spectacular in the copious amounts of blood that was spilled in his name than the crimes committed by the Ayatollah's legion of followers, somehow Hussein remained a nameless, faceless entity to the American media public, while the Ayatollah's grim countenance was seen scowling from the covers of national news magazines and television news shows all over the globe. If you wish to be reminded of some truths regarding the clashes of the Arab nations, England, etc. I suggest all of you rent and see *Lawrence of Arabia*.

To somewhat explain a few of the machinations of the internationalists a bit further, and the U.S. Central Intelligence Agency (CIA) which led to this most recent turnabout, we must look back to around 1953, the year that the CIA orchestrated a coup against Iranian Premier Mohammed Mossadegh as mentioned earlier in this writing. He was a patriot who intended to nationalize the oil fields. (Reminiscent perhaps of Noriega's intent to "nationalize" the Bush family's holdings of resort hotels, etc., in Panama?). They firmly installed in power Mohammed Reza Pahlavi, the Shah of Iran—remember him? He was murdered—after he was "given sanctuary" in the U.S.—by the CIA. They have all sorts of ways to "naturally cause" a murder. Just a month after the Shah organized his new government the U.S. rewarded him with a loan of \$45 million.

Dictator Delusions

The Shah, although he was also a brutal dictator with delusions of royal grandeur, was totally embraced by the internationalists since he faithfully served their interests. He was the CIA's lackey, and worked hand in glove with the oil companies and the international banks. Pahlavi also brought onto the scene ISRAEL, which was looking for a counterbalance to the military might of the Arab nations.

The Iranian people are not Arab although they share certain cultural traits. Islam is their dominant religion but, overriding concerns on that point, Iran is one of the most prolific producers of oil in the entire world. The Israelis made sure they had control over the Shah's regime by setting up his dreaded secret police, the SAVAK, and schooling it in advanced methods of torture and mass intimidation—right through the Israeli Mossad trainers.

It was ROCKEFELLER AND **HENRY KISSINGER** who, as secretary of state, in 1973 convinced the

Shah to impose the first round of oil price hikes which brought about the shocks that would cause so much disruption to the economies of the world. The organization of Oil Producing and Exporting Countries (OPEC), the so-called Arab oil cartel, was in fact warning the U.S. Government of the dangers of ever-increasing oil prices—you see, for it is all but hidden from you—the U.S. and Great Britain are major participants in OPEC.

Ironically, it is OPEC which is generally painted as the villain in this affair, when the oil embargo actually resulted from the efforts of the internationalist Elite to secure yet one more source of massive profit from a staple commodity.

The Shah's rule proved so onerous to Iranians, however, that one obscure holy man, the Ayatollah Ruhollah Khomeini, who had been exiled to Iraq and later took up residence in Paris, was able to lead a successful populist, nationalist revolt by little more than smuggling cassette tapes carrying his message into Iran—my friends, ***THE WORD CAN SET YOU FREE IF YOU WILL BUT HEAR!*** The purpose of the revolt was to get the U.S. and the CIA out of Iran, and to return the fate of the nation into the hands of the Iranians themselves.

Their fundamentalist Islamic sensibilities were offended by the crude imitation of Western society their imposed leader, the Shah, was forcing upon the country, and they eagerly embraced Khomeini's spiritual leadership.

Now, of course, this presented a quandary to the internationalists. Who would they champion? They settled this honor on Saddam Hussein—the dictator of Iraq. The CIA and the U.S. State Department showered their favors, telling him that Iraq's (formerly Mesopotamia's) ancient enemies, the Persians (Iranians), were seriously weakened by their revolution and Iraq could gain control of land contested for centuries by the two neighboring countries.

Iraq attacked Iran only after it received firm assurances from the CIA and ISRAEL that they would support Iraq financially and militarily.

Hussein, who is easily one of the most brutal government leaders since Stalin, waged his war with Iran in contravention of every prohibition of the Geneva Convention. He planned to resort to the use of poison gas, a ban on which had been universally honored by civilized nations since the horrors of World War I, to defeat the human wave attacks launched by the militarily inferior Iranians. As he declined to use that tact, the Israelis in the U.S. supplied vehicles and missile launchers—dumped the poison chemicals on the people in secret and then blamed Hussein.

Dharma, this machine is showing signs of trouble. I request that you begin a new document to finish this chapter/*Express*. Hatonn to standfby.

Hussein and his internationalist backers did not count on the fanatic religious zeal which would impel hundreds of thousands of Iranians to willingly sacrifice their lives to defend their homeland and their revolution.

Armed with superior military weapons provided by the U.S. and France, Iraq fought Iran to a standstill in a brutally conducted war. The difference between the Iran-Iraq conflict and all other modern strife was that it was fought largely beyond the eyes of the world media and, thus, was largely ignored by the public.

GENEROSITY ENFORCED

Although the Persian Gulf War [*Iran vs. Iraq*] ended largely in a draw, Iraq emerged as a pre-eminent military power in the Middle East—second only to Israel—thanks to the enforced generosity of you, the U.S. taxpayer.

Despite his acclaimed (although false) use of chemical weapons on Iranians—and was further accused of using the chemicals on his own people, the Kurds, an ethnic minority whose loyalty to the Hussein regime was questionable—the Iraqi dictator remained the apple of the internationalists' eyes. He remained at their beck and call because it suited his interests as well as their own.

A MAJOR COVER UP

Pay attention here for we just wrote a chapter for the current *Journal* about the *USS Liberty* and it comes up again herein in similar format in the incident, *USS Stark*. Let us have the truth about the missile attack on the frigate *USS Stark* in the Persian Gulf on May 17, 1987, claiming the lives of 37 American sailors.

The U.S. Government quickly put forth the claim that the attack was a case of mistaken identity—just like the Israeli attack in 1967 on the *USS Liberty*, which was also called a “mistake”—but the latest lie with the *USS Stark* could not be covered as well.

This was put forth as being the work of Iraqi Mirage jet fighters involved in the attack, a revelation that had initially been revealed by mistake in a wire service report, but which was then denied and censored. The official line was to be that there was only one aircraft, piloted by a confused, trigger-happy Iraqi pilot.

The even-greater dimensions of the scheme, and the following coverup, was later revealed. It was ***confirmed*** that at least one of the jet pilots WHO FIRED THE DEADLY FRENCH-MADE EXOCET MISSILES AT THE *STARK WAS AN ISRAELI*—many of whom were “on loan” to the Iraqi Air Force.

The truth, then, was clear. The attack on the *Stark* was to be another Pearl Harbor—one of the most successful snow-jobs in history—intended to rally the American public behind a holy war against Iran. The plan was for the *Stark* to be completely destroyed by the attack (just as with the *USS Liberty*), and the blame would fall on Iran.

The failure of the missiles to do their job, or, rather, the brave and quick response by the American crew to save their comrades and their ship, foiled this evil scheme. But the cover-up remained largely successful. Finally, only this year, columnist Jack Anderson tumbled to the “possibility” that there were two jets involved in the attack. This was a full three years after the incident had actually been accurately reported and brought public only to be buried and denied as preposterous—and the public ate it up like cyanide Kool-aid. Well, as you now know from the *Journals*, the Kool-aid incident was a lie also. Are any of you picking up a rather distressing pattern?

All during this time, strangely enough, Hussein remained a good guy so far as the Western media was concerned. Until, that is, his entering of Kuwait at the request of the “real” Kuwaiti leaders and his takeover control of that state’s rich oil fields, which proved to be too great a threat to ISRAELI interests as well as the international bankers and Great Britain. And so it goes.

Well, Mr. Bush’s dispatch of thousands of U.S. combat troops to Saudi Arabia armed with fighter-bombers, missiles and tanks, and backed up by a huge naval flotilla and thousands of other weapons, not only represents an unparalleled assertion of U.S. imperial might in the Persian Gulf, but marks the actual preparation for what will prove to be a prolonged and bloody war—well planned and orchestrated.

Bush dares to defend this on the grounds of “ensuring stability” for the sheikdoms of the Persian Gulf when actually the purpose is to bring into control all of the countries of the Persian Gulf. The Iraqi “aggression” had not one iota of importance relative to the real cause. This was staged to perfection and you ones are in SERIOUS TROUBLE! You have now what Kissinger/Nixon (by the way, Mr. Kissinger was instrumental in the downfall of Nixon and some day I’ll speak of that conspiracy also) set up, an outright military outpost—permanent—in Saudi Arabia.

COLLUSION

What gave the green light to this new, ominous stage of military maneuvering and intervention was the “new era of cooperation” forged with Gorbachev’s Russia over the past year. This U.S.-Russia/Zionist/Bolshevik/Banker Cartel rapprochement far outweighs anything projected to you the people. Secretary of State Baker took advantage of being “accidentally” in Russia at the time of the invasion of Kuwait to issue a joint declaration with Russia condemning Iraq, and Russia has since joined in the economic blockade of Iraq. Gorbachev’s Russia is in need of Western economic aid which would be jeopardized by any economic downturn resulting from a rise in oil prices.

Will you see and respond to the handwriting on the wall? I wonder. You have allowed the murder and mutilation of farm workers in the insecticide-infected fields without so much as cutting down on your grape consumption. You basically ignored Caesar Chavez’s food strike to call attention to the seriousness of the situation—oh, you paid half attention to the celebrities who gathered in mealy-mouthed mush at his bedside and then did nothing. We expect Dharma to get even less attention in her efforts by fasting to gain attention to the massive scheme to garner ALL PROPERTY INTO THE RESOLUTION TRUST CORPORATION THROUGH THE S&L FIASCO. Who will pay attention? In Hussein's speaking he speaks of God and goodness in every breath. Your controllers speak of economic greed, protection of your oil interests and force to bring about capitulation.

I WARN all nations—you have been deceived and you, as America, have joined with England as the most Satanically aggressive nation on the planet. “...TO CURB THE PROLIFERATION OF CHEMICAL, BIOLOGICAL, BALLISTIC MISSILE AND ABOVE ALL, NUCLEAR TECHNOLOGIES.” (MEMBERS OF CONGRESS HAVE URGED HIM TO ATTACK AND ‘USE THIS OPPORTUNITY TO DESTROY IRAQ’S CHEMICAL AND NUCLEAR WEAPONS PROGRAMS.’) “...BUT WE WON’T LET THE PLIGHT OF HOSTAGES AFFECT POLICY DECISIONS.”

Speaking of those Americans in Iraq and Kuwait, Mr. Bush said:

“OF COURSE, OUR HEARTS GO OUT TO THE HOSTAGES AND TO THEIR FAMILIES.

BUT OUR POLICY CANNOT CHANGE. AND IT WILL NOT CHANGE! AMERICA AND THE WORLD WILL NOT BE BLACKMAILED BY THIS RUTHLESS POLICY.

Right here I shall interrupt in the most attention-getting manner possible—LOOK AT THE NEWS—TODAY! ***IN AMERICA THERE IS A TRAIN OF SOME HALF-MILE IN LENGTH (MINIMUM) LOADED TO THE CAR TOPS WITH CHEMICAL WEAPONS—ON THE MOVE TO THE SEAPORT. ...the President urges various federal agencies to expedite the permitting process required for certain oil drilling projects in the Beaufort Sea near Alaska and renewed his call for Congress to allow oil drilling in the Arctic Natural Wildlife Refuge in Alaska....to accelerate the development of Alaskan energy resources without damage to wildlife...establish pipeline projects designed to bring natural gas into California in projects designed to recover hard-to-get oil.

Among steps proposed by the Energy Department to encourage conservation are calls for Americans to use gasoline with lower-octane ratings.

The President also called for efforts to increase fuel-switching. Higher oil prices are already persuading industries with dual-fuel capacity to switch to natural gas from oil. (What an interesting concept.) Energy Department officials have also looked at ways to remove barriers, such as transportation problems, that could inhibit the switching of fuels.

Then of course there would be “Tax Perks” for alternative energy productions, i.e. solar, etc.

FOREIGN OIL

I am asked to clarify amounts of actual percentages of oil imports into the U.S. and from where. Yes, I can do that but it will make you bilious because you are going to see that Iraq just doesn't cut the percentage relative to the "flap". Any single exporter could make up the difference without blinking.

The U.S. imports about 50-some-odd percent of its oil. It doesn't need to for you have a total glut. But, EVERY BARREL OF IMPORTED OIL PAYS THE OIL COMPANY A MINIMUM OF \$1.75 SUBSIDY, ACROSS THE BOARD, TAX FREE, PER BARREL. A breakdown by percentage of the top ten exporters of oil to the U.S. in 1990 (January through May): Saudi Arabia, 14.98 percent; Venezuela, 11.96 percent; Nigeria, 11.23; **IRAQ**, 7.28; Virgin Islands, 3.74; Algeria, 3.54; Angola, 3.38 and United Kingdom, 2.86.

Dharma, please locate an Editorial from one Vincent J. Ryan, and reprint it herein. To say the least, he is quite kind and understates the obvious to the full extent of wise credibility.

"PERSONAL...FROM THE EDITOR" Yes, I deliberately leave out his publication—he likes to have his head attached to his shoulders!

"Here we are, right back where we started. And, although it's too early to be certain, it is beginning to look as if things are cooling off and a diplomatic settlement might be reached, UNLESS ISRAEL GETS ITS WAY AND MANAGES TO PROVOKE AN INCIDENT THAT LEADS TO WAR (not too hard, considering the sheer numbers of soldiers and military firepower assembled in the region).

"One thing is for sure, however. That is that the United States can no longer afford to be the global Keystone Kop, protecting the interests of others and earning only black eyes and pratfalls. Our own interests have been neglected for far too long, and our needs are too overwhelming to be overlooked any longer. Enormous debt, a faltering economy, a ravaged industrial base and a crumbling infrastructure are crying out for the attention of our criminal political leaders who, in seeking the coward's solution to the problems of peace, tried to get us into war.

"Iraq was only the first. There are brush-fire wars breaking out all over. Civil war in the Philippines, South Africa and Sri Lanka, a border war between India and Pakistan, a regional war in the nations of East Africa and ethnic strife in Eastern Europe are all looming over the horizon. These are most assuredly not

our problems, but we must beware the politicians' desire to make them ours to distract us from the difficulties we face at home.

“The new period of isolation we are entering into is, as mentioned earlier, being forced upon us by the hatred we have justly earned from the world's nations by our stupid interference. It at least affords us the chance to start over again. But just think what a country we could have had now if we had looked to our own interests as the Founding Fathers counseled, spent those trillions of dollars at home or not at all, and allowed all those lives lost in needless foreign wars to have been productively lived out in peace.

“So it looks as if our innings are coming. Perhaps there's a silver lining in the black cloud of disaster the mattoids and their puppet politicians have made for America.”

Please look carefully at this message and refer back to those things in the countdown to Nuclear War One in 1982 and feel the pressure on thine toes!

You may make it for a while for Russia is so far ahead of you in Space and technology that you plan a bloodbath suicide mission if you move on into war. However, your wondrous Global Elite politicians have set you up two wondrous methods to swallow trillions of unaccounted dollars into waste—the black hole of debt and now the black hole of military war spending. How nice of you to finance your own execution and funeral and set up those criminal “NEW WORLD ORDER” leeches into full power while you bend and scrape and offer the alms of your freedoms, your *Constitution*, your property and your very lives unto Satan! They even gave you the addicting sleep potions to keep you in a stupor while they Raped, Ravaged, Pillaged and Plundered you! Worse—you took it like candy from the sweet-shoppe.

Oh yes, there is indeed a firestorm in Babylon this day!

HISTORY

For the fourth time in a decade, the American military is being sent into the Middle East. Two of these interventions, the abortive helicopter raid in Iran and the Marines in Lebanon were totally disastrous. Only on the third intervention did you achieve anywhere near your objective, protecting the Persian Gulf oil route, despite casualties—no doubt, to man, a worthy cause.

Mere technological superiority over the Middle East has not proven enough to ensure success; American leaders must also correctly assess the situation. A brilliant dissertation has been penned regarding the History of the Region in point and I shall excerpt from it for you know not that which ye do nor of that in which ye interfere.

You are dealing with a part of the world peopled with cultures dramatically different than your own. Unless you effort to understand these people, you will be violating one of the major rules for any conflict: “Know your enemy.” You have no idea of that which you are up against.

While it might be impossible to summarize a culture in brevity, we shall attempt to point out crucial differences between American and traditional Arab thought patterns.

EVERYTHING IS RELATED

Some cultures see everything as related—violate a taboo in one area, and all aspects of life and the community will be sorely affected. Other cultures see more separation between different aspects of life.

American culture, being a mixture, seems to be in the middle, although increased specialization and judicial mandates to separate religious morality from all levels of government and education are creating a more atomistic culture.

Arab culture is even more atomistic, with a tendency to view life and the universe as a series of static, concrete and disjunct entities, loosely linked but without an organic interrelationship. Society is not an organic whole, but an association of separate groups held together by the ground below and the government above but owing no relationship or loyalty to each other. Towns are agglomerations of quarters, houses, clans and guilds only rarely with a corporate identity of their own. It is hard to get a citizenry to fight for a nation-state, given this world-view.

RELIGION AS A WAR TOOL

Unlike the European societies which are increasingly reluctant to use God as a goad to kill and conquer, the Islamic faith of the Arabs, since the beginning, has glorified holy wars (jihads) against unbelievers (infidels). This not only includes fighting non-Moslems, but has also included using the development of fanatical sub-sects and cults to stir rural elements into a holy war against rulers and city-dwellers.

In a historical study of causes of wars versus casualties, around 10 percent of a population has been willing to die in the name of religion while less than 2 percent have been willing to die to preserve economic interests.

While it would be difficult for any Arab leader to rally his population to defend his nation-state, if Hussein can rally the Arabs in a true jihad against unbelievers, his followers will accept a casualty rate beyond Americans willing to die in order to protect pipelines.

“ISLAM” MEANS “TO SUBMIT”

Islam (the word) means “to submit”. Submission is seen as a positive virtue, to be practiced with loyalty and enthusiasm. Authoritarianism is respected and obeyed, whether it is a rigid theology, legal system, or dictator.

Thus Americans may denounce Saddam Hussein At-Takriti as a thug and a bully who used chemical weapons against his own people, but these facts do not lessen the Arab duty to submit to him. Nor has the benevolence of the Kuwaiti rulers increased the duty of their citizens.

Only the demonstration that Saddam Hussein or the Kuwaiti royal house is acting in an un-Islamic manner

would lessen the average Muslim's duty to submit, since revolt has almost always been based on religious grounds. As the fall of the Shah of Iran shows, this is a tool that can be used most easily against secular rulers who cooperate with the West.

To Europeans and Americans, "nationalism" is an easily understood term—loyalty to your people and culture and a recognition of a territory as rightfully belonging to a society. In the more atomistic Arab culture, the concept did not exist until 1914 when the British appealed to Arab nationalism to encourage them to rebel against the Ottoman Turks.

What was generated was a nebulous pride and recognition of a common language, history and culture which is shared throughout the Arabian Peninsula and parts of North Africa. Europe then offended this fledgling nationalism by seizing control of most of the Middle East, drawing borders not recognized by the Arabs and ruling them through mandates.

Even when given independence, Arab nations found themselves dominated both militarily and economically by Western forces. While prospering economically, they bitterly hated being ruled by non-Moslems, and incipient nationalism has combined with traditional religious fervor. The presence of Israel, European infidels, recalls the 200-year presence of crusader states.

Thus today Arab nationalism tends to combine an antipathy to Europeans, Americans and Israelis with a loyalty to a large area and population which have little or no relationship to current borders. One is reminded of Europe's Middle Ages, where kings and lords controlled as much territory as they could hold, but the average citizen owed only personal and local loyalties and a general sense of belonging to "Christendom".

Saddam has attempted to rally this (Arab) nation to his support. He is not the first to do so. President Gamal Abdel Nasser of Egypt used it successfully but died in 1970. Col. Muammar el-Kadaffi has attempted to use it, but his nation proved too vulnerable to outside attacks. Saddam is operating from Baghdad, a traditional center of the Arab world (and almost on top of the old city of Babylon!), and has backed the Palestinians and battled Iran to a standstill. This makes him a strong, even heroic figure to many, many Arabs.

As a secular ruler originally belonging to the Baathist party which was founded by a Christian and a Moslem, he could be vulnerable, but his strong stand against Israel and the West has strengthened his legitimacy in the eyes of most Arabs. Just as the crusader states fueled 200 years of Arab strongmen, you should not be surprised if the presence of Israel similarly generates a string of leaders exploiting the widespread nebulous anger of Arab nationalism.

Even if Saddam is successfully suppressed by the West, **THERE ARE MORE POTENTIAL LEADERS AND STRONGMEN—MORE THAN YOU CAN IMAGINE IN YOUR NIGHTMARES!**

PERSPECTIVE

Americans have only a short span of history and you tend to interpret all events from the perspective of the recent past. You explain most worldwide events in terms of the last 50 years—World War II until present day.

Thus, President George Bush denounces Saddam as “Hitler”! Do you see the correlation and the limited perspective?

The Arabs, however, belong to a far older culture; Iraq in particular being a center of civilization for thousands of years. You are dealing with a culture therefore which has a perspective of at least 2,000 years. To understand them you must know a little about their history.

HISTORY LESSONS

Mesopotamia was first part of the Parthian, then (AD 226) the Persian (Sassanid) Empire. The area was politically united with Iran. Under the Parthians, Mesopotamia was one of several provinces, but under the Persians, the city of Ctesiphon, near Baghdad, was the imperial capital. Economically, the area was a major trade center between Persia and Roman principalities.

AD 500-AD 1000: Mesopotamia was the center of the Persian Empire, which expanded to include the eastern Mediterranean shore and Egypt (AD 600-616). It was then conquered by Islamic armies (AD 636). Initially, the empire centered in Medina, then Damascus, while expanding to include North Africa, Spain, southern France, Pakistan, Afghanistan and parts of Central Asia.

In 749, the Ummayyad rulers were replaced by the Abbasids, who centered the empire once again in Mesopotamia, in Baghdad.

Arabic became the sole language of thought and culture in these realms, and even when areas became independent or dominated Mesopotamia, as Persia did near the year 1000, the caliphs and Baghdad retained a position similar to the popes and Rome in medieval Europe.

AD 1000-AD 1500: This begins the millennium of Turkish domination of the Middle East. Mesopotamia was conquered by the Seljuk Turks, breaking all ties with North Africa and uniting it with Persia and Anatolia (AD 1071). The Turks, a nomadic people, were allotted landholdings, transforming the Arabs into a feudal society.

In the late 1100's Mesopotamia became independent under the Abbasid caliphate but this interlude was merely a precursor to the turning point in Mesopotamian history, the savage Mongol-Turkic invasion of 1258. Hulagu, grandson of Genghis Khan, ordered the destruction of irrigation systems which had been in place since Babylon, reducing Iraq into steppe and swamplands.

Peasants were massacred and for the next 80 years Mesopotamia was a ravaged, poverty-stricken province of Persia. Any chance at recovery was destroyed by Tamerlane (a Tatar or Turk) in 1401 with the massacre and razing of Baghdad. The latter part of the century saw Mesopotamia isolated from all but the eastern Caucasus and torn by warfare between the “Black Sheep” and “White Sheep” Turks.

Baghdad and Mesopotamian cities plummeted in economic importance, and Egypt, dominated by the Turkic Mameluke sultanate, successfully resisted the Mongols, destroyed the crusader states and became the dominant economic and political power of the Arab world.

AD 1500-NOW: In 1508, Mesopotamia was conquered by Persia but this union was ended in 1534 when Baghdad was conquered by the Ottoman Turks. The Ottomans ruled from Istanbul (Constantinople) and dominated North Africa west to Morocco and south to Sudan, as well as European territory from the Balkans to the northern shore of the Black Sea.

Mesopotamia became the empire's turbulent eastern border, torn by wars with Persia and nomadic Arab tribes. From 30 million people in 1200, it had been reduced by centuries of warfare to a population of only 1.8 million by 1800.

Constantinople and Cairo were the cosmopolitan centers of wealth. The empire gradually decayed and by the late 1880's and early 1900's Europeans began to occupy the empire's African and Arab lands.

Turkey's defeat in World War I led to the division of the Middle East under French and English mandates, with the kingdom of Iraq being given to the Hashemite family under a British mandate.

The country became independent in 1932 but was crushed by the British during World War II when it tried to ally with the Axis nations. In the late 1950's the monarchy was overthrown and the last British protectorates (along the western and southern coasts of the Persian Gulf) were given their independence in the following year.

OUTLOOK MOST GRIM

The current situation in Iraq is grim for two reasons. As most readers know, Iraq is suffering from crippling war debts and needs cash for imports. The second reason, more profound for a river people and largely unacknowledged in America, is that Turkey and Syria have been damming the headwaters of the Tigris and Euphrates.

Syria and Iraq almost went to war when the Syrians created Lake Assad and completely stopped the flow of the Euphrates downstream, causing massive suffering among 3 million Iraqi farmers.

Turkey is currently filling the giant reservoir behind the Ataturk Dam. Both Syria and Turkey are undergoing the second year of a severe drought so the amount of water available is limited anyway, and when this is combined with the upstream dams, the Euphrates is so low that in many places one can walk across it without getting wet. With both Turkey and Syria planning to build many more dams, Iraq faces a dire future.

Americans tend to perceive borders drawn since World War I as permanent. From the Iraqi perspective, however, these borders are fairly recent and drawn by colonial powers which they have since rejected totally. Moreover these borders restrict Iraq to an abnormally small territory and no sea access.

During the last 2,000 years, Mesopotamia has spent 95 percent of its history incorporated into a bigger territory than today. Over 50 percent of that time Mesopotamia controlled most or all of the Tigris and Euphrates headwaters. For at least 80 percent of its history it has controlled Kuwait and the mouth of the two rivers. Only during the British and Mongol dominations have the two areas belonged to different sovereignties.

A FEW CONCLUSIONS AND
SHOCKING RELATIONSHIPS—
GO READ THE PROPHECIES!

Just looking at these observations doesn't necessarily raise any sympathy for Iraq, but does present its point of view and explain the explosiveness of the current situation. The Iraqis, between a shortage of water and cash and a large growing population, face total starvation.

By returning to a coalition with Kuwait, Iraq can raise money and oil prices—along with the Kuwaitis. Saddam's actions, while condemned publicly by Arab leaders (who have been bought off by the Westerners), offend neither the local morality or religion. However, European and American intervention do offend large elements of the population, since you are neither Arab nor Islamic.

If Saddam is a modern man and economic consideration can force him to retreat, you may be successful in your current endeavor.

If, however (and I suggest you REALLY STUDY THOSE PROPHECIES IN *REVELATION*), Arab nationalism and fanatical Islamic hatred of the infidel can be aroused against you, you may face very large casualties, not just from Iraqi military but from terrorists from every Arab nation as well for the nations may be suppressed by the "bribed" and wealth-laden leaders coalesced to the West, but the terrorists will unite and you will have never witnessed such spillage of blood—until the rivers turn red, perhaps? I suggest you also take into consideration the drying of the Euphrates and pay a bit of attention to the "oil" which could certainly hold a magnification clue as to the "luxuries" spoken about.

You err in calling Saddam a "Hitler" for what you witness is a probable becoming of the new "Saladin", leading a holy war against what Arabs will consider the "NEW CRUSADES". Hitler's power lasted less than a dozen years—HOLY WARS LAST FOR GENERATIONS! THINK UPON THESE THINGS MOST CAREFULLY FOR YOUR DAYS BECOME NUMBERED IN THE HOURGLASS.

The Bush Administration has required that the Israeli government maintain a low profile while the U.S. military buildup continues in the Persian Gulf region. The reason is that American officials do not want to send out the truth while they try to marshal a united Arab front to counter the military aggression of Iraq's Saddam Hussein At-Takriti. Further, they keep a big ridiculous facade of your Secretary of State Baker vacationing in unknown parts (during the most critical time your world has ever known), and proclaim to not really know his whereabouts—while he is shuttling between Iran and Israel making deals with your

money and word, your nation and soldiers' lives. It's called "LET'S MAKE A DEAL".

KNOW BY THAT WHICH
IS NOT PROJECTED

Publicly, Bush has so far sent out public cover-up of any discussions of the gulf crisis with Israeli Prime Minister Yitzhak Shamir, other than of Iraq's Saddam. Interestingly enough, Bush has openly talked with EVERY OTHER LEADER IN THE REGION. Further, it was also decided at the last minute to cancel a planned August 9 visit to Washington by Israeli Foreign Minister David Levy to discuss the Israel-Palestine situation. Clearly, photographs of Secretary of State James Baker meeting with Levy would not be viewed with favor in the Middle East—so, we go on "vacation" to secret "retreats" and meet with Shamir AND Levy—to hide from you the world.

There also have been concerns expressed about Israel's bragging that the Iraqi "invasion" of Kuwait proves that the real problem in the Middle East is not its handling of the occupied territories, but that of those nasty and aggressive Arab states. And, Israeli newspapers have been editorializing since August 2nd that Israel's special relationship with the U.S. has been REAFFIRMED by the current Middle East crisis.

U.S. Government projected concerns over Israel's handling of the uprising in the occupied territories had given new weight to demands for a separate Palestinian state, while at the same time leading to speculation America's policy in the region might actually be undergoing change. Perish the thought of such a policy which would bring forth integrity.

EVEN-HANDED

Arab states have, of course, long complained about the U.S. bias toward Israel and many Washington based diplomats were beginning to express hope that the solidarity being exhibited toward Iraq might have some tangible results. The Bush Administration might, perhaps, be considering a more even-handed approach as plans are apparently in the works to supply several Arab states with sophisticated armaments. And, dear ones, where is all the funding going to come from for all this unConstitutional gift-giving? Do you never wake up and see what is being done to you?

Egypt is believed to be in line to receive more than \$1 billion worth of F-16 jet fighters, air-to-ground missiles and cluster bombs. Saudi Arabia, the United Arab Emirates, Oman, Bahrain, Turkey and Morocco also would receive nice new and abundant supplies of weaponry.

With better armaments these U.S. allies would be better able to withstand aggression in the region and deployment of American forces would not be needed. However, Congress must approve all such deals and, if past history is any example, might reject the administration's plans as posing a threat to Israel. Well, that is, of course, foolish, for Israel is part of the planning committee. The ultimate intent is to attack Russia and precipitate all out Global Control.

The U.S. has, since being the first government to extend recognition to Israel on May 14, 1948, consistently backed up that state with massive infusions of money and every type of technology and military supplies. It is a result of one of the few instances in your recorded world history in which a domestic

special interest group has had a measurable effect on a sovereign government's foreign policy.

PRO-ZIONISTS' PLANKS

The scam has been to fool the Jews more than anyone else in your world and it has worked beautifully. The Jewish people, having been scattered about the world, thought they were at last finding truth and unity for a Godly cause. They didn't realize that the Zionists have no care nor concern about the Jews as a people and will get rid of them FIRST. Israel is, by far and away, the leading foreign aid beneficiary, receiving more than \$3 BILLION in CASH (in 1990, so let's not think this is old hat—except that the amounts continually GROW). But look what else good old U.S.A. taxpayers did in addition: Egypt received about \$2.3 BILLION, with Pakistan at \$627,000,000 Turkey at nearly \$614,000,000 and the Philippines some \$614,000,000. These are the so-called Big Five in U.S. foreign aid. HOWEVER, ISRAEL'S *PER CAPITA* GROSS NATIONAL PRODUCT (GNP) IN 1989 WAS ESTIMATED AT \$6,210.! The closest to that incredible “nothing” figure was Turkey with \$1,110 a year. Then came Egypt with a per capita GNP of \$760, the Philippines with \$570 and Pakistan with \$350. Therefore, I fear a very good case could be made that U.S. aid is aimed largely at maintaining Israel's economy, and its standard of living.

The largest Arab recipient of foreign aid, Egypt, was rewarded with that allocation ONLY AFTER IT SIGNED THE CAMP DAVID ACCORDS WITH ISRAEL!

HOPEFUL

Arab states have, of course, long been aware of the bias in U.S. Middle East policy toward Israel and even now are only mildly hopeful of a change—actually, they know the hope in the face of increasing “support” is indeed foolish but they have not the individual strength to stand against the monster. They have allowed the enemy to divide and conquer! They know they have not a prayer of changing the policy because the world knows the power the Israel lobby wields over a compliant, money-hungry U.S. Congress who has long since ceased to function under the national laws of the *U.S. Constitution*.

About 100 pro-Israel Political Action Committees (PACs) have been set up in the past 20 years to funnel money to key legislators. The Arab-American Institute in Washington has stated that the 25 senators with the most consistently pro-Israel voting records received an average of \$91,000 per election cycle from these groups—that is a hefty income bonus every two years.

Therefore, the U.S. position on the question of Palestinian statehood seems destined to follow the thinking of Israel's government. This means that, so long as pro-Israel PACs provide money to members of Congress, the U.S. Government will believe the fiction that Israel represents U.S. interests in the Middle East—no matter what happens in the occupied territories of anywhere else.

An excellent case in point is the unhappiness over the dialogue with the Palestine Liberation Organization (PLO) that began at the end of the Reagan Administration. The Israeli government strongly objected, despite the obvious fact that talking with one's enemies is clearly the best way to resolve differences.

However, the talks were suspended earlier this summer in the wake of a guerrilla attack blamed on the PLO faction which was actually done by the Israelis themselves. Many members of Congress in the pay of the Israel lobby demanded that the contacts be severed because the PLO did not react properly to the incident. The legislators persisted in their demand even after it became KNOWN the small group responsible was opposed to the U.S./PLO dialogue and that Israel had actually precipitated the entire incident.

ISRAEL HAS ALREADY PRACTICED
AND REHEARSED FOR ARMAGEDDON

We shall speak of this subject and then I am going to outlay the bad, bad news about the VULNERABILITY OF YOUR FORCES TO CHEMICAL WEAPONS—THE PICTURE IS INDEED HORRENDOUS AND YOUR PENTAGON KNOWS IT AND HAS, IN FACT, HANDFULS OF SECRET REPORTS SUBSTANTIATING THE FACTS.

The splendor of old Baghdad made it a tempting prize for other less civilized peoples who heard of it. It was not long before ancient Baghdad became a focal point of warfare, involving especially the Mongols

and Turks. Rapacious greed destroyed much of the beauty which had once been the hallmark of Baghdad. Constant warfare took its toll and over the centuries the Saracen Empire decayed in culture and power. The ancient irrigation systems were destroyed and what was once a Garden of Eden began to turn into a wasteland. In 1516 Baghdad fell permanently to the Turks and the once magnificent Saracen Empire faded into the sands of a man-made desert. Could it happen to your Imperial Valley of California??? How about your San Joaquin Valley? How about the area of Texas growing fields known as Deaf Smith County where the aquifer is now becoming contaminated? Ponder these things—further, the Super-Collider is being set up to destroy the rest of the Texas area in that same location.

TODAY'S BAGHDAD

The Iraqi Baghdad of today is a far cry from that wondrous and fabled city of old. Modern Baghdad, Iraq, lies on the east bank of the Tigris across the river from the ruins of the ancient city. Even so, the Baghdad of today does have certain things in common with the Baghdad of old. Modern Baghdad has been struggling once again to become a city of science, culture, and power and, like the ancient city, modern Baghdad is faced with a powerful enemy who is determined to destroy it.

On June 7, 1981, an aerial strike force of 14 warplanes started their jet engines in the country that calls itself Israel. Eight of them, at least, were AMERICAN F-16's loaded with one-ton bombs. The other six were AMERICAN F-15's. The F-15's were air superiority fighters and were to fly along with the F-16's for protection from any possible defenders of the intended targets. After the planes took off, they refueled from their accompanying aerial tanker for the long war-flight they were about to undertake.

For days beforehand, the Israeli planes had been flying training exercises designed to look like the early part of the real raid. As a result when the war raid was launched, it looked like just another drill.

To maintain the surprise, the Israeli strikeforce thundered eastward over Jordan at high altitude, mimicking Jordanian Air Force procedures. Next, the Israeli fighter bombers raced into and across northwest Saudi Arabia. Following secret orders from the Pentagon, the American-manned AWACS radar plane patrolling over Saudi Arabia did not report the Israeli intrusion into Saudi air space—for it was planned to pull off this attack in secret and escape public knowledge of the perpetrators.

Thanks to this preplanned cooperation by the U.S., the fate of the Israeli target in Baghdad was sealed.

The Israeli F-15's and F-16's streaked across the Syrian desert of Iraq on the deck below Iraqi radar. As they neared Baghdad, they appeared to rise from nowhere out of the Iraqi countryside as they climbed to begin the attack. At 6:30 P.M. Baghdad time, a hail of one-ton bombs began raining down on the Iraqi nuclear reactor which was then under construction but did have nuclear material on site. Within a matter of minutes the reactor facility lay in ruins.

The Israeli bombing raid into Iraq was a momentous event, the kind of thing you expect to hear about IMMEDIATELY through your electronic news media. Instead, the world remained IGNORANT OF THE RAID FOR ANOTHER FULL DAY! Iraq imposed a news blackout about it at first for totally military reasons. The raid had come without warning or provocation and the Iraqis were not sure what else Israel might be about to do. Further, the cover-up was under way to make it appear Israel did not do the

attack. But there was a blunder and the Israeli planes were identified immediately, precluding other than sham attempts at later cover-up.

NOW WHY DO YOU SUPPOSE YOUR ARMIES AND MILITARY STRENGTH WERE NOT SENT IN TO “PROTECT” AN INVADDED NATION WHEN THE FACTS WERE BLATANTLY OBVIOUS BEFORE THE ENTIRE WORLD? THERE WAS NO MORE THAN A PAT ON THE HEAD FOR GOOD WORK!

The U.S. Government knew about the raid beforehand but, true to form, the U.S. said nothing to the world about what it knew. It was left to Israel itself to publicly announce the raid, which it finally did in triumphant glowing terms when it was obvious to the world who had done the dastardly deed.

Around the world the reaction was revulsion, shock, and condemnation—and no wonder. For one thing, Israel was trying to justify its acts of war in arrogantly self-righteous terms. Israel complained that Iraq was building a reactor—but wanted everyone to forget that HER OWN NUCLEAR CAPABILITY WAS BUILDING IN LEAPS AND BOUNDS. Israel was fully nuclear capable and operational in 1981. Israel had refused to sign any Nuclear Non-Proliferation Treaty, which Iraq had signed. The Iraqi nuclear facility had been inspected regularly by the International Atomic Energy Agency during its construction phase when any violations would be impossible to hide, but Israel—which has never once submitted to international inspection—bombed the plant anyway.

Beyond the matters of international law and simple justice, Israel had also opened the proverbial Pandora’s Box in more ways than one. For one thing, Israel had broken an unwritten taboo against attacks of any kind against nuclear facilities. Now the nuclear power plants of the world had been made fair game and the outcome of such attacks would be unthinkable.

Military, paramilitary, or terrorists attacks on nuclear power plants would no longer be unthinkable, thanks to the Israeli raid into Iraq, and this includes the nearly a hundred nuclear power plants operating in the U.S.

By secretly working with the Israelis in the Iraq raid, the U.S. Pentagon sowed the seed of nuclear terrorism in your own country through direct participation.

Most important of all, the Israeli raid on Iraq’s nuclear plant was a dry run for a far more important raid. This was the coming Israeli attack on Saudi Arabia’s oil fields. The nuclear destruction of Saudi Arabia’s oil fields was far from a new idea, as we have already pointed out to you.

Over six years prior the plan revolved around the so-called “Sinai Accord” involving Egypt, Israel, and the U.S. Two hundred or so Americans were in the Sinai under that agreement and they were intended to become the focus of an incident to set off war in the area. The actual attack on Saudi oil fields was to be carried out using Cobra helicopter gunships with special air-to-ground atomic missiles.

The plan was part of the ongoing joint plan between the long-time Rulers of the U.S. and the Soviet Union for world domination. As originally conceived, the plan called for a nuclear capping of Saudi oil fields sometime in 1976. It was not carried out at that time because the secret alliance between the U.S. and Russia started coming apart in 1976. The old Rockefeller allies in Russia, the Bolsheviks, were being

quietly overthrown there. In their place a new ruling group was taking over. Russia's new rulers hated the Bolsheviks and had been expelling them from Russia in great numbers and, because America's then Secret Rulers, the Rockefellers, had supported Bolshevik rule in Russia from 1917, Russia's new rulers were taking defensive actions. The result was the still secret UNDERWATER MISSILE CRISIS of 1976. The collapse of the Rockefeller-Soviet alliance during 1976-1977 brought a reprieve for Saudi Arabia.

But now, the American/Bolshevik/Zionist government has carried over the plan to destroy Saudi oil fields. The plan has been continuously updated and revised for maximum strategic value as the new international situations are impacted by changes. You are now in the Middle of the final really BIG PLAN and the outcome which seems to center around actions of Hussein are actually centering around what Russia will do!
