BUSH OLIGARCHY CONTINUES TO MURDER AMERICANS

The alleged suicide of Dr. Bruce L. Ivans, repeating the staged suicide and murder of CIA Dr. Frank Olson, CIA Chief William Casey, probably Ken Lay, and others in advance of allowing them to blow the whistle or testifying under oath: Given the preponderance of the evidence and the recurring pattern, I believe these human beings were all targeted for black-ops assassinations. The supposed suicide of Dr. Bruce L. Ivans possesses the historical earmarks of CIA assassinations and cover-ups and demands a criminal investigation and the immediate enactment of impeachment proceedings against the Bush-Cheney administration and any Republican shill in the Democratic Party intent on obstructing justice; e.g. Nancy Pelosi. In addition since 2000 and with a Protective Person’s Status under Title 18 of the United States Code, my life has been directly threatened while passively sanctioned for assassination through the “slow kill” methods of psyops terrorism and CIA “no-touch” invisible physical torture techniques committed by the culpable agents and agencies of the U.S. Government under the Bush-Cheney administration. Standing alone I expect to be murdered by some staged method caused by culpable components within the U.S. Government infrastructure. Nearing that end I remain without any elected or legal representation from my Senator, Ron Wyden and Congressman, David Wu. Multiple federal felonies and crimes against humanity have and are being committed against myself, other Non-Criminal Federal Witnesses and American citizens targeted for torture. Contrary to the false sworn testimony presented during a U.S. Congressional hearing by WitSec administrators James F. Clark and Sylvester Jones, government witnesses [non-criminal, criminal and custodial] have died in and after having exited the Federal Witness Protection Program from medical neglect and suicide that was caused by the erosive effects of being unknowing human test subjects in a clandestine torture program sired from the CIA MK-ULTRA Program; i.e. the Federal Witness Protection Program [WitSec].

America’s ruling multigenerational oligarchies [Bush, Henry Ford, John D. Rockefeller, Joseph Kennedy; et al] financed the rise of Nazism since the 1920s and through WWI and WWII against

The agents of the U.S. Government have both deliberately and negligently outed Lee Vin Bah’s active covert status to serve as a passive sanction for his assassination through the creation of a mortal threat environment. These attacks intensified when Bah was a cancer patient in 2004. Both John F. Clark, Director U.S. Marshals Service and Sylvester Jones Assistant Director, Witness Security & Prisoner Operations have lied under oath before the U.S. Congress concerning the deaths of federal witnesses. Within the Federal Witness Protection Program [a perversion of language], since 1970, 1,080 non-criminal federal witnesses within this torture experiment that was sired by a tentacle of the CIA’s MK-ULTRA mind control program, have become the unknowing test subjects and laboratory control sample for the applied methods of psyops terrorism and invisible physical torture techniques on an unseen minority within the U.S. civilian population. Lee Vin Bah will never forgive or forget that the government he once served has destroyed his life and family and while remaining in mortal danger is actively seeking asylum as a refugee under a protected person’s status from the Government of Canada.

the United States of America. This globalized Nazism evolved into corporatism or the fascist capitalism that has continued to consume the dream and promise of America through the virtual death camps of democracy; e.g. bait and switch mortgages, corporate bailouts at the tax payers expense, outsourcing industry to cause a downward spiral in the job market, inflated food and fuel prices in the lead up to a pump and dump of commodities stocks, and any mechanism to absorb the generational wealth of the American middle class to create a peasant culture.

To better help understand the lineage of Nazi clones within the Bush oligarchy: Prescott Bush is George W. Bush's paternal grandfather and George H. W. Bush's father. The name sake of both President Bush I and II was George Herbert Walker Bush, Prescott Bush's father-in-law, George H. W. Bush's grandfather and George W. Bush's great grandfather. These are the historical and present day fascists that began their ongoing Rovian Blitzkrieg against the fabric of America on September 11, 2001.

The American people with their patriotism have unknowingly been financing their own deconstruction of their constitutional democracy with their tax dollars by unleashing a rabid pack of cloaked Nazi parasites within the U.S. Government infrastructure where they have thrived for far too long and now must be exposed and adjudicated before the nation has been completely lost. Many of the ruling oligarchies and corporatists in the U.S. today with deep ties to big oil and the banking industry, helped finance the rise of fascism in Nazi Germany and the ongoing destruction of the United States of America being experienced in the present moment. Karl Rove's father literally helped build the Nazi SS Birkenau death camp. These traitors have continued causing the death of Americans and other innocent human beings since before, during and after WWI, WWII and forward through the perpetuation of the medium of war for profit and oil piracy. These same sponsors of terror supported the anti-Semitic genocide of over six million human beings during the Jewish Holocaust. They instrumented "Operation Paperclip" to import 1600 SS Nazi war criminals to America where they continued their genocidal experiments under CIA black projects. John McCloy, High Commissioner of Occupied Germany and protégée of the Rockefellers, was later appointed the head of the World Bank after overturning seventy-five percent of the Nuremberg Tribunals. The brothers Allen and John Foster Dulles [Washington-Dulles Airport, a point of debarkation to several blacksite facilities] with their considerable influence over the CIA and U.S. State Department, covered the Bush family's treasonous tracks and helped develop the CIA MK-ULTRA Program that later produced the tentacle known on the surface as the Federal Witness Protection Program [a perversion of language]. Hidden from public scrutiny, these U.S. Government black projects continue to use honorable American citizens like Non-Criminal Federal Witness, No.: 7001 as the unknowing human test subjects within a laboratory control sample for the applied sciences of psyops terrorism, "no-touch" invisible physical torture techniques and the development of "slow kill" technologies [the Phoenix Projects] by targeting innocent political and human rights activists on U.S. soil with radiation weapons that employ microwave and radio frequencies through existing consumer electronic devices [telephones; movies and films; flashing message boards; traffic signals; lights; sound recordings; computers; the internet; and televisions that are being harnessed to HD cable boxes for other reasons; etc.] and other deployable weapons systems on ground, sea, air, and space.

One of these top secret mobilized "Direct Energy" weapons, referred to as the "Pentagon's Ray Gun" or the "Boss Surveillance System" was partially demonstrated in its non-lethal form on two 60 Minutes' broadcasts that originally aired on March 2, 2008 and was updated on May 30, 2008.

The U.S. Pentagon deliberately lied to 60 Minutes producers concerning their alleged Non-Lethal Ray Gun developed by military defense contractor Raytheon at Kirtland AFB, AFRL/DE [Air Force Research Laboratory, Direct Energy], was made operational in 2003 and tested at Moody Air Force Base in southern Georgia. The feel good psyops story was the Bush-Cheney administration's attempt at humanizing genocidal experimentation by creating a flowerful image in the public's mind that was not unlike that of a hippy in the 1960s sticking a daisy in the rifle barrel of an M-16. dollars to produce military weapons that "kill"; they do not build weapons systems to tickle targets. In fact while testing the alleged "non-lethal" weapon, which all comes down to the settings used by the operator, the DE Ray Gun targeted and fried a 500 pound cow and a goat. Easily this direct energy weapon could terminate a 175 pound human being. The weapon was not deployed in the illegal war in Iraq, because the Bush-Cheney administration required American military service members to die to perpetuate the villain verse hero scenario and a war for profit. Had the direct energy weapon been deployed to Iraq 4000 murdered U.S. military service members might not turn into 8000 along with over 100,000 other innocent human beings.

The black project requiring a Top Secret/SCI plus Security Clearance also produces unclassified published data in the form of technical report through other government agencies. "Published October 1, 1997 and entered into system May 4, 2001; OSTI ID: 350505; AD-A--359509/XAB; AFRL-DE-PS-TR--1998-1073; Air Force Research Lab., Kirtland AFB, NM [United States]; 30 DIRECT ENERGY CONVERSION ; MHD GENERATORS; ELECTRIC POWER; PLASMA DIAGNOSTICS; LORENTZ FORCE; RESEARCH PROGRAMS; MICROWAVE EQUIPMENT: The field of High Power Microwaves [HPM] has evolved as a result of advances in the field of pulsed power, which has made pulses of electrical energy available that can drive HPM sources to gigawatt levels. One of the most compact forms of pulsed power involves the storage of chemical energy in the form of explosive charges. Explosive magnetohydrodynamic [MHD] generators are electrical power sources, which convert the kinetic energy of moving plasma into useful electrical energy through the magnetic portion of the Lorentz force. This report describes research conducted by the Air Force Research Laboratory to test specific designs of explosively driven magnetohydrodynamic generators. The goal of the research was to investigate the use of gigawatt generators in driving reactive loads appropriate to diode, and ultimately HPM applications. Two test series were performed, the first of which consisted of experiments on a low voltage generator and the second of which had the goal of scaling the existing design to higher voltage while retaining the reactive-type load. The complex problem of diagnostics of the plasma in this explosive test was addressed using fast, temporally resolved, plasma measurements, as well as spectroscopic plasma constituent measurements." This from the minds that would create a focusable nuclear weapon and help cause global warming to perpetuate natural disasters to elicit the deconstruction/reconstruction model of corporatist money profiteers or the jackbooted fascist thugs causing the global genocide of every living thing.

Although living in the present moment becomes the future we are compelled to investigate our past and the U.S. Government's importation of Nazi SS methodologies to America. These genocidal programs designed to deconstruct and reconstruct [the corporatist war profiteer formula] have been developed and tested on American citizens, minority groups [Non-Criminal Federal Witnesses] and have been expanded both nationally and globally for the creation of the "New World Order." The U.S. Army and CIA secret laboratories at Fort Detrick located in Fredericks, MD, constitute one of many such blacksite location in the U.S. The misnomer of the Federal Witness Protection Program is another black-ops project that intensely tortures all government witnesses with special attention targeted against Non-Criminal Federal Witnesses who currently number an estimated 1,080. The clandestine WitSec Program uses American tax payers' dollars to murder human beings in plain sight of the general public while shielding its culpable network of agents and coconspiratorial agencies with duplicitous use of national security protocols. National security letters subvert the rule of law in the last four case brought by the ACLU's Washington, D.C. office. ACLU Nation President Nadine Strossen was promised summary reports from those case. The applied genocidal formulas used against Non-Criminal Federal Witnesses and Criminal and Custodial Federal Witnesses by the Federal Witness Protection Program, like MK-ULTRA, systematically and systemically destroys the human mind through "slow kill" methods by the erosion of the individual sense of self-identity that replaces all hope with suicide programming while converting a life into an existence of adjunct human slavery within a virtual death camp environment where we are continually faced with lethal deportation back to our birth identities within an unequal and paralleled America brought about by an unjust system and the culpable actions of our U.S. Government tortures.

U.S. Army/CIA Dr. Bruce L. The syndicated Bush oligarchy like any continuing criminal enterprises nearing a conclusion has recognized its own heinous vulnerabilities while attempting to evade criminal prosecution and impeachment with the same comparative cowardice as that of Saddam Hussein hiding in a spider hole from U.S. forces.

of George W. Bush for Murder. Stalling from immediately bringing impeachment proceedings is a demonstration of the U.S. Congress's willingness to allow the continued deconstruction of America and to perpetuate the corporatist model for deconstruction and reconstruction profiteering. The meaning of life is to become more human in a manner that at least attempts to respect the human being in all people – it is not about the exclusive interest of the few over the many or the gluttonous earmarks of inhuman sociopaths.

For the American people and all of humanity, if I cannot bring this story to forefront of public attention before November 2008 through my growing contacts in the U.S. and Canada, then to make the world a better place, I am prepared to defect. Having already been threatened with assassination by culpable federal agents and agencies under the Bush-Cheney administration and recognizing that crows are black everywhere, still there are sovereign foreign nations where I am certain a new home awaits with the guarantee of meaningful employment that includes academic prosperity and various communication platforms for marketing the Black File 7001 story. The world must be told of the U.S. Government's development of torture programs and the evolution of virtual death camp environments. As an American veteran of voluntary covert national service and Non-Criminal Federal Witness, No.: 7001 with a Protective Person's Status issued under Title 18 of the United States Code by U.S. Attorney General, Janet Reno, myself and others have been targeted with CIA "no-touch" invisible physical torture techniques, psyops terrorism tactics and other technologies by the culpable agents and agencies of the U.S. Government under the Bush-Cheney administration. No honorable human being or minority group should be targeted with these genocidal formulas by the degenerate posers within the U.S. Government black-ops infrastructure.

Before the world of human beings, I suspect my story and that of the other American victims of U.S. Government torture programs known to me, will likely render the United State's human rights policies completely hypocritical and laughably irrelevant in the eyes of humanity and the American people; not that their votes actually count for anything under the current corrupt election system that is neither publically funded without being privatized or devoid of the Electoral College and Delegate/Super Delegate fixers.

Note there are 89 separate varieties of Anthrax stored in the United States. Dr. Ivans had worked intensely with the FBI to identify the markers used in the 2001 U.S. Postal Service, Anthrax attacks as having been produced in the Fort Detrick's top secret laboratory. The negative back stories being presented about Dr. Ivans, including an alleged history of donations to an anti-gay rights group are attempts at squelching public fears and to cause complacency in the minds of Americans to prevent demands for further investigations. A genuine investigation with a "living witness" could produce evidence leading back to the Bush oligarchy having used Anthrax as a weapon of mass destruction against the United States of America to perpetuate the psyops attack against the American people following the localized strikes on September 11, 2001.

The Anthrax attacks through the U.S. Postal Service that delivers mail everywhere in the nation, was the black-ops method for causing all Americans to feel they were touchable and next in line to be murdered after the 911 attacks and the botched clandestine demolition of World Trade Center Building No.: 7. The Bush administration's ancestral origins are firmly rooted in Nazism with a historical syndicated migration into global corporatism. The Bush oligarchy is attempting to bury the bones of their treason as quickly as possible before the vermin abandon ship after November 2008. The Whitehouse should be remodeled and cleansed of the Bush energy before President Obama and his family takes office and possession of their federal residence.

We will never forget, rest or remain silent until George H.W. Bush, George W. Bush and their globalist organized crime family have been criminally prosecuted and adjudicated with the proper sentencing due traitors and genocidal war criminals.

Currently the media seems to have missed the link between the alleged suicides of Dr. Ivans and Dr. Olson. This press statement will be released forthwith to the media and included within a larger document within the next few days. The same "Suicide Paradigm" of Dr. Bruce L. Ivans took place on or about November 28, 1953 with Dr. Frank Olson at the top secret lab at Fort Detrick, MD where the CIA performed "brainwashing" and other torture experiments during the MK-ULTRA Program [the Manhattan Project of torture programs]. Since that time the same facility has developed other black projects in torture, terrorism and the technologies for same; e.g., the psyops portion for the New Phoenix Program to target political activists and dissident civilians.

The original Phoenix Program was used to assassinate suspected Vietcong sympathizers in a systematic manner that worked affectively during the Vietnam War. Subsequently this became the blueprint for the current black-ops targeting of thousands of loyal Americans using state of the art microwave [MW] and radio frequency radiation [RFR] weapons. The motivation to suppress domestic dissidents and to assassinate American patriots who demonstrate opposition to the "deep state", stems from the perception that challenge against corporatist war profiteering constitutes treason in the rabid minds of the anti-American political pimps within the "New World Order." This philosophy is stated very clearly in the MindWar paper written by NSA General Aquino. The indiscriminant killing of the Phoenix Program continues on American soil today. continually face Virtual Lethal Deportation through Vicarious Extraordinary Rendition back to my birth identity and certain death, I have sought retroprosity for my Protective Person's Status through the United Nations High Commissioner for Refugees [UNHCR] and asylum from torture in Canada.

Dr. Bruce L. Ivans alleged suicide and the probable cover-up of his black-ops assassination compares with the earlier death of Dr. Frank Olson, a CIA scientist at the same top secret facility in Fort Detrick, MD. Dr. Frank Olson was unknowingly dosed with clinical strength Lysergic Acid Diethylamide, sequential order 25 [LSD-25] during the CIA MK-ULTRA Program to cause a psychotic breakdown and Olson's placement in a New York sanitarium for his recovery that I suspect was a measure to prevent whistle blowing about the torture of human test subjects and the pretext for covering up an assassination. In hindsight Dr. Olson's sanitarium stay after being poisoned with LSD-25 [aka LSD or acid] and his alleged suicide that followed, compares in the reverse with Dr. Bruce L. Ivans's suicide with the government's sudden after the fact release of an alleged psychiatric history of homicidal tendencies and supposed donations to an anti-gay rights group [psyops to disenfranchised a percentage of the concerns from members of the progressive movement] with both cases creating plausible deniability for committing murder under the guise of suicide.

Note that during the early 1970s, a source close to the classified laboratories at Fort Detrick, MD, and a person who invited me to a university lecture hosting Timothy Leary, revealed and in fact displayed a plastic container with 500 tablets of CIA produced LSD-25 pressed into robin's egg blue M&M Candy shapes that were distributed throughout the United States to monitor various populations as a laboratory control sample. Following that first CIA test, a second batch of LSD-25 was released containing the poison known as Strychnine produced from the Strychnos nux vomica tree; Americans died as a laboratory control sample. The laboratory scientist now referred to as 'my source' was an older person and at that time my life experiences were limited to studies of the marine environments and trying to discover my place in the universe.

Given my personal firsthand and ongoing experiences in the Black File 7001 matter and the subsequent discovery of other condemning evidence, we must consider facts regarding the use of pharmaceutical and chemical companies during the MK-ULTRA Program and beyond. The pharmaceutical and chemical companies actively participated in the CIA MK-ULTRA Program, which tortured and caused the subsequent deaths of human test subjects; many were children. The pharmaceutical companies have knowingly produced Rx prescription medications in advance of a known diagnosable disease like "high cholesterol" to create a panicked market using medical doctors and professional print media publications to validate the rhetoric written by advertising agencies as their own proven research findings under the color of the "white lab coat" persona. The pharmaceutical companies have knowingly increased their bottom-line profit margins by inventing and marketing placebo prescription medications that produce zero medical benefit and further cause doctors to prescribe additional drugs to their patients who are often left to suffer or have died in the meantime.

Given these factors and the criminal arrogance of the Bush-Cheney administration, if a CIA scientist would and could step forward to testify without being assassinated, I believe the evidence will prove that a CIA black-ops enlisting the Pharmaceutical Industry, did developed the HIV virus that causes AIDS and released that biological weapon of mass destruction on the world as a global version of the "Black Gonorrhoea" developed during the Vietnam War where U.S. military service members were marooned on an island in the Philippines or the "Tuskegee Study of Untreated Syphilis in the Negro Male" also known as the Tuskegee Syphilis Study, Pelkola Syphilis Study, Public Health Service Syphilis Study or the Tuskegee Experiment. The latter clinical study was conducted between 1932 and 1972 in Tuskegee, Alabama, in which 399 poor and mostly illiterate African American sharecroppers were studied to observe the natural progression of the syphilis disease if left untreated. In the early 1980s as a uniformed law enforcement officer, I observed the those destructive effects on an elderly African American man

in the south who had been infected with syphilis and left to die; it was and is another form of genocide brought to America during "Operation Paperclip" and developed by the Nazi proponents still infesting the U.S. Government infrastructure. All of this is part of the same layered clandestine mechanism that murdered Dr. Frank Olson under the same black-ops suicide veil being created around Dr. Bruce L. Ivans.

Dr. Frank Olson was release from the sanatorium and on the day before his return to Fort Detrick, MD, late in the evening, Dr. Olson allegedly threw himself through the glass window from his 10th floor room at the Statler Hotel, New York. The death of Dr. Olson was ruled a suicide like that of Dr. Bruce L. Ivans. Dr. Olson's son, Eric Olson, a Maryland clinical psychologist complained for a number of years that the story of his father's death was as strange as the television series the "X-Files."

In 1975 the contaminated Rockefeller Commission, established by President Ford to examine the extent of the CIA's illegal domestic operations, revealed that an "unnamed army scientist" had died after CIA operatives experimenting with mind-bending drugs had secretly slipped him a dose of potent LSD-25. An uproar ensued during the hearing and the scientist was identified as Dr. Frank Olson. The Rockefeller oligarchy like the Bush family, Henry Ford, and Joseph Kennedy were all heavily involved with Adolf Hitler, the Nazi industrial complex and a syndicated consortium of businesses. The perpetuation of migratory genocidal fascism to the U.S., propagated the CIA MK-ULTRA Program [Bluebird, Artichoke and Monarch], which in 1970 grew another tentacle under the misnomer of the Federal Witness Protection Program.

Eric Olson convinced authorities that his father's death was a criminal matter and in 2004 a court order was issued to exhume the body of Dr. Frank Olson.

Dr. Frank Olson had been buried with a sealed coffin after the government stated that his body had been so badly mutilated in the fall that it would not be right for the family to see him. However when the casket was opened a lifetime later, Eric Olson recognized his father at once. Dr. Frank Olson had been embalmed and his face was unmarked and untroubled. Dr. Frank Olson had not been hurt the way the government said he had. This same or similar pattern of lies continues being told by the Bush-Cheney administration; e.g., the staged Jessica Lynch story and rescue [damsel in distress], the Pat Tillman friendly fire incident and American soldiers being electrocuted while taking showers in Iraq with the cover story they had carried an electronic device in the water while bathing.

"A new autopsy confirmed Eric Olson's impression and entirely contradicted the findings of the first inquest. Carried out by a team led by James Starrs, Professor of Law and Forensic Science at The National Law Centre, George Washington University, it could find no sign of the cuts and abrasions that the first autopsy said had been caused by crashing through the window glass."

"On the other hand, there was a haematoma, unrecorded at the first post mortem examination, on the left hand side of Dr. Frank Olson's skull. This had been caused by a heavy blow, James Starrs decided, probably from a hammer, before the fall from the window. Starrs and his team concluded that the evidence from their examination was "rankly and starkly suggestive of homicide."

"Although the team did not say so—because it could be only supposition—someone had struck Dr. Frank Olson on the head with a hammer, smashed open the window, probably with the same hammer, and had then thrown Olson out. But the new autopsy findings were certainly enough for a New York public prosecutor, Stephen Saracco, to win the right for a grand jury to begin hearing the evidence he had uncovered. If the jury, too, found the evidence of murder compelling, then Saracco requested that it should hand down indictments for murder and conspiracy to murder."

"Saracco, an ambitious, aggressive lawyer with no fear about taking on the American establishment, says that the men he wants named in the indictments will include some of America's most respected CIA veterans and, if the grand jury agrees to his request to widen his investigations, former officers of the British Secret Intelligence and Security Services as well."

Early in the 1990s the grand jury issued subpoenas to then CIA Chief William Casey, requiring him to appear and answer questions regarding the crimes against humanity committed during MK-ULTRA and the circumstance surrounding the death of CIA chemical scientist, Dr. Frank Olson with the U.S. Army secret laboratory at Fort Detrick, MD.

On Saturday, April 27, 1996, after Saracco won the right to a grand jury hearing, Colby who realized that he would be forced to give evidence, vanished from his country retreat in Rock Point, Maryland about forty miles south of Washington. It looked as if he had left in a hurry: the lights and the radio were still on, his computer was still running, and a half finished glass of wine was on the table. The next day his empty canoe was found swamped on a sand bar. Five days later on Monday, May 6, 1996 divers found a body identified as Colby's. He had apparently been the victim of a boating accident. The subsequent inquest found that he died from drowning and hypothermia after collapsing from a heart attack or stroke and falling out of his canoe, and there was no further investigation. We all know how much any evidence presented by the U.S. Government is actually worth given the overwhelming corruption exhibited under the Bush-Cheney administration.

In 1978 another CIA officer, John Paisley, also vanished near Colby's home in another boating accident. The following week after Paisley's abandoned boat was located, a body with a gunshot wound to the head was also recovered. The condition of the body made it impossible to precisely identify the victim. That area of Maryland has become a conspiracy blacksite.
