PRESS STATEMENT

RE: TOP SECRET CLASSIFIED U.S. GOVERNMENT AND FEDERALLY SEALED RECORDS LEAKED. INTELLECTUAL PROPERTY ELECTRONICALLY REMOVED FROM MY COMPUTER LAST NIGHT. MY MOTHER'S HOME SUBJECTED TO DAYLIGHT ROBBERY INVESTIGATED BY FORMER POLICE DEPARTMENT OF THE NOW U.S. NAVY NCIS AGENT CONVEYING THREATS FOR THE BUSH-CHENEY ADMINISTRATION.

On August 13, 2008, my life has again been directly threatened by the culpable agents and agencies of the U.S. Government, my intellectual property electronically removed from my personal computer and my mother's home subjected to a daylight robbery.

Black File 7001 is being produced using my writer's pseudonym to afford a small degree of privacy and extends far beyond the long-standing tradition of Congressional courtesy, which dictates that the current federal senators and representatives are afforded the opportunity to respond to their constituents of the districts from which they were elected.

Since 2000 with the rise of syndicated global corporatism [fascism], as an honorable American citizen with a Protective Person's Status granted by U.S. Attorney General, Janet Reno under Title 18, U.S.C., I have endured beyond my human limits, the coconspiratorial actionable offences of terrorism and torture committed by the criminal agents and agencies of the U.S. Government under the Bush-Cheney administration. This duplicitous use of national security protocols with criminal intent knowingly involves the administrative officers of the Federal Witness Protection Program, James F. Clark and Sylvester Jones; WitSec Inspectors, John W. Dubois aka "Jigs" [Portland, Oregon], Allan S; et al [Portland, Oregon and Seattle, Washington]; U.S. Navy NCIS agent, Lawrence H. M. aka "M" [East Coast]; et al; the Social Security Administration's Sensitive Operations Division and their agents Ken B; et al; T-Mobile, Inc. [a German Corporation]; and possibly Comcast, Inc.

Note there is a contaminated Social Security Disability Benefits case on appeal and pending an immediate ruling by the Federal Civil Court, Seattle, WA. The matter possesses the dirty hands of criminality by the U.S. Government and was used as a method for causing psyops terrorism and CIA "no-touch" invisible physical torture. Additionally the culpable U.S. Government actors deliberately committed federal felonies in this matter while unsealing my classified file without authorization and violated the WitSec mandate by creating a mortal threat environment around a government witness that further serves as the Bush-Cheney administration's passive sanction for my assassination; i.e., the contract murder of an honorable American veteran of voluntary covert national service with an alleged protective person's status as Non-Criminal Federal Witness, No. 7001.

From my youth I have always believed that the true enemies of humanity were those who caused good people to live in fear. Cowardice to perform one's duty for our mother country and all who are cradled within her in my opinion remains inexcusable. It is not my nature to hate, but **SENATOR,**

Black File 7001 by Lee Vin Bah is the Rosetta Stone of U.S. Government torture programs and the evolution of virtual death camp environments predicated upon the genocidal experiments performed in Auschwitz-Birkenau during the Jewish Holocaust. In 1999, Lee Vin Bah, a former covert agent of the federal government with the FBI, became "Non-Criminal" Federal Witness No.: 7001, and discovered the latest methods of psyops terrorism as a U.S. torture victim subjected to "no touch" or invisible physical torture techniques. Lee Vin Bah exists in adjunct human slavery within a highly tangible virtual death camp environment that is void of constitutional civil liberties and inalienable human rights. A subordinate federal agent directly under the Bush-Cheney administration threatened the government's "invention" of a criminal charge if Bah publishes a book with the comment that people in high places are afraid to death their programs will be destroyed. Culpable federal agents through the commission of actionable offences in political retribution have made it impossible for Bah to find employment after being disabled during two trauma accidents caused by or in the service of the U.S. Government. These same federal agents remain shielded from criminal and civil prosecution under the duplicitous use of Title 18 of the United States Code and National Security Protocols. The agents of the U.S. Government have both deliberately and negligently outed Lee Vin Bah's active covert status to serve as a passive sanction for his assassination through the creation of a mortal threat environment. These attacks intensified when Bah was a cancer patient in 2004. Both John F. Clark, Director U.S. Marshals Service and Sylvester Jones Assistant Director, Witness Security & Prisoner Operations have lied under oath before the U.S. Congress concerning the deaths of federal witnesses. Within the Federal Witness Protection Program [a perversion of language], since 1970, 1,080 non-criminal federal witnesses within this torture experiment that was sired by a tentacle of the CIA's MK-ULTRA mind control program, have become the unknowing test subjects and laboratory control sample for the applied methods of psyops terrorism and invisible physical torture techniques on an unseen minority within the U.S. civilian population. Lee Vin Bah will never forgive or forget that the government he once served has destroyed his life and family and while remaining in mortal danger is actively seeking asylum as a refugee under a protected person's status from the Government of Canada.

RON WYDEN and **CONGRESSMAN, DAVID WU** should both be ashamed for their shared silence in this matter after well over 100 notices. I'm not just fighting for myself; I am defending the American people against the foreign backed domestic enemies who have treasonously attacked the United States of America since September 11, 2001. The heroes of the American people, Senator Barack Obama and Congressman Dennis Kucinich have both sent personal letters of support from their offices addressed to me in my legal name, which tells me they are doing more than just scanning copy. Maybe someone is fighting as hard for me as I have fought to protect the American people in unnamed battles on U.S. soil that twice caused trauma and my disability. Senator Wyden and Congressman Wu will you stand with me in the continued performance of our shared duty for the American people?

Given the egregious nature of this case that is deeply rooted on impeachable ground, I am requesting an immediate media platform to convey the Black File 7001 story before the international court of public opinion and am seeking the representation of a literary agent to promote my professional interests. All non-propagandized freedom loving national and international news media sources and my fellow writers and journalists are invited to contact me at your earliest convenience. Do not let November 2008 come and go or nothing will change for the better – we should all move forward together against the fascists of this modern era.

The FBI defines terrorism as: "the unlawful use of force or violence against persons or property to intimidate or coerce a government, the civilian population, or any segment thereof, in furtherance of political or social objectives."

An FCC complaint has been served against T-Mobile, Inc. for their part in a RICO conspiracy to conduct warrantless wiretapping along with culpable components within the U.S. Government infrastructure since on or before January 20, 2006 [provable]. The culpable actors under the Bush-Cheney administration have deliberately leaked classified and federally sealed documents and/or information to T-Mobile, Inc. for their coconspiratorial commission of acts of psyops terrorism and CIA "no-touch" invisible physical torture. Each of these acts constitutes a federal felony count.

If this matter ever reaches a federal courtroom, I will personally seek economic and non-economic damages in the minimal amount of one hundred million dollars [100,000,000.00] against the U.S. Government, T-Mobile, Inc.; et al. With the evidence now in my possession, the discovery process will not be subverted by national security letters and in that regard I am agreeable to discuss the legal representation of a qualified attorney or civil liberties organization.

Following a telephonic communication with an agent of the FCC who advised me that she was issuing a complaint notice to T-Mobile, Inc. and after making my next online payment to T-Mobile, Inc., I received a "death threat" through the T-Mobile, Inc. text message receipt for that online payment. T-Mobile, Inc. also changed the short code number from my WitSec 7001 classified identification number leaked to that German corporation and used by them since January 20, 2006 to the short code 456. Given that the U.S. Government has been conducting an illegal electronic surveillance of everything that I write and publish as documented through complaints and notices to state and federal agencies, the numeric 456 recognizes a "psyops death threat" with the number 4 in Chinese being synonymous with the word for death and 56 being the year of my birth – this is not a coincidence and numeric codes are often used in the black ops community for a host of psyops and other reasons.

On July 15, 2008, I visited my Social Security attorney during a scheduled meeting to retrieve deliberately commingled federally sealed documents placed together in an act of felony political retribution by the agents and agencies under the Bush-Cheney administration. On the morning of that same day, the U.S. Attorney in Seattle, WA and a representative of the Social Security Administration suddenly contacted my Social Security attorney and notified him that my file had been left unsealed [a federal felony] and open for public examination since January 2001 and was being

resealed pending a federal judge's signature to a motion dated July 14, 2008. The file is now sealed again.

Yesterday, August 13, 2008, following my press release concerning the alleged suicide of Dr. Bruce L. Ivans and faked suicide/murder of Dr. Frank Olson from the same secret laboratory at Fort Detrick, MD, I "immediately" received a call from a Maryland telephone number that left no message [301-237-Removed].

This morning, August 14, 2008, for the second occasion and the first event on my new personal computer, I discovered that the machine had been electronically penetrated last night for the theft of my intellectual property and the removal of the single research file containing all of the MLA Citations for the Black File 7001 book draft. The file was saved within my browser with approximately ten others and the Black Project: MLA Citations file was the only one removed. It is not recoverable and demonstrates the Bush-Cheney administration's further validation and endorsement of the Black File 7001.

Also this morning and prompting a rewrite of the original version of this press statement, my elderly mother telephonically contacted me and stated that her home had been targeted for a daylight robbery on Tuesday, August 12, 2008. While resting on a large swing between two old and trees on her property and with her back towards the front porch of her home, the neighbor's dog started growling and barking aggressively. My mother turned around to find a black male subject, approximately 40, standing five feet from the front porch and addressed the man by asking him what he wanted. The man stated that he wanted to know if she needed him to clean the gutters or yard. My mother answered no thank you and the subject smiled and left. Later that evening my mother realized the subject had already been inside her home and had taken several gold necklaces and high end watches. It is unknown if this attack against my family is an expansion of the ongoing federal crimes being targeted against me. The thief never opened the jewelry box containing several diamond rings positioned between the items he had taken. The local police department and the officer who investigated the robbery had formerly been assigned to narcotics and likely new and/or had worked with the cross-sworn police detective that was assigned to our covert FBI team. That individual has since retired and is now the U.S. Navy NCIS agent who in other reports has attempted a larceny during the sale of my personal vehicle; was gifted with a Harley-Davidson show motorcycle to dispose of for his daughter's college fund that instead purchased a home entertainment system; had a first wife with a brother on the Seattle Police Department; the first wife was a reported heroin addict and continued hanging around under the color of blackmail; has always lived above his pay grade; manipulated the NCIS human resources criteria during the ongoing hiring process to eliminate the competition; is someone I have long suspected as being a mole; and is the same agent who made the telephonic threat not to publish my book or face the "invention" of a criminal charge by the government.
