PRESS STATEMENT

Re: BUSH-CHENEY ADMINISTRATION TELEPHONICALLY ORDERS U.S. SPECIAL FORCES UNIT "NOT TO KILL" OSAMA BIN LADEN AFTER TARGETED AND CLEARLY IDENTIFIED WITH OTHERS. U.S. Military team ordered to withdraw without engaging. U.S. soldiers requesting combat pay were told the Pentagon had reclassified their mission as a black operation and therefore the team would not receive extra pay, because they were never in the region. Pakistani President Pervez Musharraf resigns days ahead of impeachment in parliament with the U.S. ally's attempts to impose authoritarian rule on his turbulent nation; and another scapegoat avoids possible assassination. Impeachment of the Bush oligarchy by the U.S. House seems to be a thought without action and a beautiful flower that bears no fruit. Nancy Pelosi about to celebrate another facelift with American voters left pondering how one lifts what they have lost forever.

Black File 7001 is being produced using my writer's pseudonym to afford a small degree of privacy and extends far beyond the long-standing tradition of Congressional courtesy, which dictates that the current federal senators and representatives are afforded the opportunity to respond to their constituents of the districts from which they were elected. Senator Ron Wyden and Congressman David Wu have failed to respond to over 100 notices that federal crimes are being committed against me by culpable agents and agencies of the U.S. Government under the Bush-Cheney administration. My life has been threatened and I am targeted for assassination while remaining an invisible American citizen and minority existing in a parallel and constitutionally unequal nation within the United States of America; I have NO REPRESENTATION.

Beyond the headlines I am under attack by the outlaw and treasonous components within the Bush oligarchy that have intensified their actionable offences against me nearing the end of their overthrow. Without those of you in the U.S. Congress contacting me to offer assistance, my life is in danger of being assassinated before I am able to share my firsthand true story. Many of your states directly benefited from my voluntary covert national service that caused me to surrender a highly promising academic future to protect Americans and innocent human beings around the world. There is no hope left in America for me other than to see my child complete college before I leave the world.

Understand those who are charged under the law with my protection are the most significant and actual terrorist criminal threat confronting me with their creation of a mortal threat environment to further serve as the U.S. Government's passive sanction for my assassination. Speaking directly to the U.S. Congressional members, I do not include you in these threats on my life and our torture as human test subjects within an unseen minority group of 1,080 American citizens who are Non-Criminal Federal Witnesses; unless you fail to rise on our behalf. Subpoena me to

Black File 7001 by Lee Vin Bah is the Rosetta Stone of U.S. Government torture programs and the evolution of virtual death camp environments predicated upon the genocidal experiments performed in Auschwitz-Birkenau during the Jewish Holocaust. In 1999, Lee Vin Bah, a former covert agent of the federal government with the FBI, became "Non-Criminal" Federal Witness No.: 7001, and discovered the latest methods of psyops terrorism as a U.S. torture victim subjected to "no touch" or invisible physical torture techniques. Lee Vin Bah exists in adjunct human slavery within a highly tangible virtual death camp environment that is void of constitutional civil liberties and inalienable human rights. A subordinate federal agent directly under the Bush-Cheney administration threatened the government's "invention" of a criminal charge if Bah publishes a book with the comment that people in high places are afraid to death their programs will be destroyed. Culpable federal agents through the commission of actionable offences in political retribution have made it impossible for Bah to find employment after being disabled during two trauma accidents caused by or in the service of the U.S. Government. These same federal agents remain shielded from criminal and civil prosecution under the duplicitous use of Title 18 of the United States Code and National Security Protocols. The agents of the U.S. Government have both deliberately and negligently outed Lee Vin Bah's active covert status to serve as a passive sanction for his assassination through the creation of a mortal threat environment. These attacks intensified when Bah was a cancer patient in 2004. Both John F. Clark, Director U.S. Marshals Service and Sylvester Jones Assistant Director, Witness Security & Prisoner Operations have lied under oath before the U.S. Congress concerning the deaths of federal witnesses. Within the Federal Witness Protection Program [a perversion of language], since 1970, 1,080 non-criminal federal witnesses within this torture experiment that was sired by a tentacle of the CIA's MK-ULTRA mind control program, have become the unknowing test subjects and laboratory control sample for the applied methods of psyops terrorism and invisible physical torture techniques on an unseen minority within the U.S. civilian population. Lee Vin Bah will never forgive or forget that the government he once served has destroyed his life and family and while remaining in mortal danger is actively seeking asylum as a refugee under a protected person's status from the Government of Canada.

testify by remote access on C-SPAN, if my story and the evidence was not true the culpable components within the Bush oligarchy would not continue their relentless attacks. In some cases I have used reverse investigative techniques against these criminal agents to cause an anticipated reaction, which also indicates they have expanded their coconspiratorial base to include younger and less experienced federal personnel while possibly layering themselves away from the initial action – that onion must be peeled.

Goodness is punished by this fascist administration and criminal misconduct and incompetence rewarded with a box load of Medals of Freedom and no-bid clandestine contracts shielded from public scrutiny under national security. My voluntary covert national service, which continues beyond a five year long undercover assignment with the FBI that never afforded one day off also recognized my suffering the two trauma accidents that left me disabled. Presently the conclusion of the final unjust act by the coconspiratorial culpable agents and agencies regarding the outcome of my Social Security Disability Benefits appeal is about to take place the Federal Civil Court in Seattle, WA.

Since 1999-2000 and after entering the Federal Witness Protection Program as Non-Criminal Federal Witness, No. 7001, I have increasingly been displaced within the nation of my birth as an invisible minority and refugee existing in an unequal parallel as a constitutionally disenfranchised non-person who as an unknowing human test subject within a clandestine federal program funded by taxpayer dollars has continually endured beyond my human limits the actionable offenses of psyops terrorism and torture by culpable agents and agencies of the U.S. Government under the Bush-Cheney administration. My life has been converted into an existence of adjunct human slavery within a virtual death camp environment and I am hanging on by a thread.

Immediately, I require a media and political platform. Additionally and having twice been a sworn law enforcement officer prior to working in the FBI, my fingerprint records are therefore maintained within both FBI fingerprinting databases. Therefore, I am preventing from applying for a concealed weapons permit and urgently require that either my fingerprint records be federally sealed as this commingles my clandestine identities or that I be issued a warrant of appointment as a U.S. Deputy Marshal without arrest powers to afford the legal right to remain armed anywhere within the United States of America or U.S. territories on land, sea and air.

The U.S. Congress must honor this request or it will in affect be signing the order for my execution and sanction for my assassination. The blackops' jackals within the "deep state" government stage suicides and murder human beings at my level; they do not afford resignation under threat of impeachment.

Again my life is continually being threatened with an increasing degree of actionable offenses at every level and for a second time I have been electronically attacked for the theft of my intellectual property by the Bush-Cheney administration that has threatened me not to publish my book titled Black File 7001 under their "invention" of a criminal charge.

Pressed into the misnomer of the Federal Witness Protection Program as Non-Criminal Federal Witness, No. 7001, I discovered a clandestine torture program sired by the CIA MK-ULTRA Project. Since 1999-2000 and with the rise of fascism in America, I have been inhumanly targeted with multiple actionable offences of psyops terrorism and CIA "no-touch" invisible physical torture techniques by the culpable agents and agencies of the U.S. Government under the treasonous Bush-Cheney administration.

The syndicated Bush oligarchy recognizes a longstanding bloated pride for their family's support of Nazism that evolved into Corporatism while Americans and other innocent world citizens died during WWI, WWII, the Jewish Holocaust, September 11, 2001, and the genocidal illegal wars in Afghanistan and Iraq. This for the perpetuation of their war profiteering and oil piracy while using the villain verses hero scenario and the good cop/bad cop mechanism of deconstruction and

reconstruction to simultaneously cause additional layers of psyops terrorism and torture. As an Italian Jewish American, I recognize the state of the nation and the world as having already been walled-off in the Ghettos and herded onto the boxcars that began arriving eight years ago at the slaughterhouses of democracy. Inalienable human rights mean nothing to the godless fascists infesting the global infrastructure of which the Bush oligarchy is a harem whore component. During the selection process these vermin have caused the genocide of the American middle class and much of the planetary population through the global creation of virtual death camp environments with many misnomer titles.

THE U.S. GOVERNMENT DOES TORTURE: Include my invisible face along with those of the other 1,080 Non-Criminal Federal Witnesses to the over six million victims of the Jewish Holocaust and the other torture victims used within U.S. Government black projects as the unknowing human test subjects within genocidal experiments that began in Auschwitz-Birkenau [the latter was built by Karl Rove's father] with the rise of Adolf Hitler and Nazi Germany. The Bush oligarchy and other well-known ruling families still flourishing within the U.S. Government today imported Genocidal Fascism to America under "Operation Paperclip" with 1600 of their Nazi SS war criminal friends, which they shielded as they are those who continue committing actionable offences against me and other Non-Criminal Federal Witnesses. Once here the Nazis became Corporatists and continued their genocidal development as the CIA MK-ULTRA Program, which spread like the poisonous tentacles of an octopus of death into Operation Phoenix, Monarch, Bluebird, Artichoke, the Federal Witness Protection Program, Global Plantationism, Economic Enslavement, the Deconstruction and Reconstruction company store model of the Military Industrial Complex, and other black projects to unconstitutionally benefit the corporate minority at the expense of the majority who are "We the People." Each of us as a laboratory control sample and virtual death camp victim has experienced and endured psyops terrorism and torture techniques beyond our human endurance from the concentrated formulas tested against us. Government witnesses have died both in and after having exited the Federal Witness Protection Program from medical neglect and suicide caused by the lifelong erosive effects that destroys the living soul of a human being through the replacement of the individual sense of self-identity with suicide programming. In their diluted forms, these same genocidal practices are being systematically applied on mass against America and the world by the syndicate Bush oligarchy and their coconspiratorial partners that attacked our nation on September 11, 2001. Without someone willing to unlock the death camp gates of the WitSec Program and assess meritorious economic and non-economic damages for our human restoration as veterans of voluntary covert national service while respecting our Protective Person's Status under Title 18 of the United States Code, then we will wrongfully die as first degree murder victims existing in the stasis of adjunct human slavery without any of the equally rights or the possibility for a future that is entitled every person under the U.S. Constitution.

Under Title 18, of the United States Code, I was granted a Protective Person's Status by former U.S. Attorney General, Janet Reno who trusted me enough to issue orders authorizing the neutralization of domestic and narcoterrorism targets operating on U.S. soil at my discretion. My active covert status has been outed many more times than that of Valerie Plame Wilson by federal agents and agencies making duplicitous use of the shielding afforded behind national security protocols. Unthinkably this prevents me as a U.S. torture victim and an American citizen from fully naming the culpable actors without written authorization from the current U.S. Attorney General who remains a puzzled angel when asked if waterboarding [controlled drowning] is torture.

The WitSec Program stated in an e-mail that under Title 18, U.S.C. that providing the full names of the criminal actors operating within the U.S. Government's infrastructure would constitute a federal felony punishable by a \$5,000.00 fine and 5 years in prison or both per count, since exposing the guilty could place their clandestine lives at risk. These same culpable federal agent an agencies remain shielded behind the same national security protocols that prevent me from identifying them outright while they continue to commit multiple federal felony counts against me

while outing my covert status; threatening my life; illegally reverse targeting me under FISA for warrantless wiretapping; leaking my federally sealed and classified information to T-Mobile, Inc. and others; electronically committing the theft of my intellectual property to destroy my research for Black File 7001; erased the pathways that would enable me to find employment and complete my university degrees while adjudicating my Social Security Disability Benefits claim with duplicitous legal standards and erroneously crafted evidence under letters of complaint by their own federal judge; and coconspiratorially committed these and other actionable offenses as methods of psyops terrorism and CIA "no-touch" invisible physical torture techniques to destroy me as a person through systemic genocide.

Theoretically when shot at within an allegedly free society, at a minimum you have the right to defend yourself, but not in the unequal parallel where I exist in the State of Oregon or the United States of America and again especially without the representation of Senator Ron Wyden and Congressman David Wu. Within my skill sets, the culpable enemies of the American people recognize me as having been one of the most effective covert operators to have ever served the American people. These same outlaw government agents under the Bush oligarchy are cognizant that I am not a criminal while they torture and terrorize every aspect of my existence in an effort to herd me into the arena of criminality where they hope I will dirty my hands; this will not happen and it is the culpable members of government who have left the trail of evidence for their own indictments and convictions.

Therefore I am again going on record as remaining unprotected with an active covert Protective Person's Status granted under Title 18 of the United States Code and having been left to defend myself against the foreign backed domestic enemies of the American people and the United States of America who remain shielded by their duplicitous use of national security protocols while continuing to attack every level of my existence; and whereas I have been twice sworn as a law enforcement officer and my fingerprint records are therefore maintained within both FBI fingerprinting databases; and whereas my identity was covertly changed without removing or sealing my fingerprint records, I am requesting for the purpose of carrying a concealed weapon and aiding me in the securing of possible employment that my fingerprint records be sealed or otherwise removed and/or that I be granted a warrant of appointment as a U.S. Deputy Marshal without arrest powers to affect the same purpose as a concealed weapons permit on land, sea and air within the borders and territories of the United States of America. Urgent Congressional support is requested to help neutralize the threats made against my life by the culpable agents and agencies of the U.S. Government under the Bush-Cheney administration.

The complete list of crimes committed by the U.S. Government is too long to include within this manifesto, but on or about July 14, 2008 the U.S. Attorney and a representative with the Social Security Administration's Sensitive Operations Division in Seattle, WA notified my Social Security disability attorney they were having my file resealed that had been illegally unsealed and left open since January 2001. The events conducted during my Social Security Disability Benefits hearing are so egregious that a federal judge issued four letters of reprimand against the coconspiratorial actors within the WitSec and Social Security Administration's Sensitive Operations Division. Social Security Benefits were awarded and punitively withdrawn in political retribution following my refusal to the Bush-Cheney administration's threat to "invent" a criminal charge against me if I publish my book [Black File 7001] that was conveyed by U.S. Navy NCIS agent [L.H.M] during the unlawful use of a communication facility. This occurred three weeks in advance of beginning a yearlong series of chemotherapy and radiation treatments for Hodgkin's Lymphoma cancer. John W. Dubois [name authorized for release by the U.S. Attorney, Portland, Oregon and WitSec Headquarters], my first WitSec Inspector was released from federal prison for his conviction of the theft of government funds, began stalking me, confronted me with a veiled death threat, and later accosted me by the arm in a local Costco while I was near death from chemotherapy treatments. The U.S. Department of Justice before it was prostituted under the Bush-Cheney administration had previously requested my assistance to investigate Dubois. Dubois volunteered that as a federal felon he was still communicating with his former partner and

a major culpable actor in this case, Allan S. [Seattle, WA] about classified WitSec business involving government witnesses. The Social Security claim became truncated after the Appeals Board in Falls Church, VA reported losing my illegally unsealed classified file two years later. The SSA's own federal judge stated in writing that I will never receive a fair hearing. The contaminated case that was made so by the dirty hands of the U.S. Government is now facing an immediate ruling in the Federal Civil Court, Seattle, WA and would benefit from Congressional oversight and an independent investigation in this matter.

On August 12, 2008, the home of my elderly mother was subjected to a daylight robbery that clearly seems to be an expanded psyops mortal threat message against my family.

On August 13, 2008, following my press release concerning the alleged suicide of Dr. Bruce L. Ivans and faked suicide/murder of Dr. Frank Olson from the same secret laboratory at Fort Detrick, MD, I "immediately" received a call from a Maryland telephone number that left no message [301-237-8182].

On August 14, 2008, for the second occasion and the first event on my new personal computer, I discovered that the machine had been electronically penetrated the night before for the theft of my intellectual property and the removal of the single research folder containing all of the MLA Citations for the Black File 7001 book draft. The folder was saved within my Firefox browser with approximately ten others and the Black Project: MLA Citations file was the only one removed. It is not recoverable and demonstrates the Bush-Cheney administration's further validation and endorsement of the Black File 7001 book project.

Additionally my computer displayed the telltale signs of having been targeted with the surveillance system known as the Digital Collection System Network [DCSNet] while having been disrupted by a pulse energy device or electronic bullet that caused my Outlook Program to stop working and destroyed one of my external hard drives. Each time an attempt was made to backup 14GB of data from my documents, I was alerted by an error message stating the hard drive had been subjected to a power surge; i.e., energy pulse. Some of that technology originated in the top secret laboratory at Fort Detrick, MD. A few weeks earlier critical appointments vanished from my Outlook calendar during other empirical intrusions.

On August 15, 2008, Comcast, Inc. converted my account that has always cost \$78.00 per month into \$155.00 per month and attempted to arguing this had always been the case, which may or may not appear so on their computer if altered by the U.S. Government. Comcast, Inc. was the ISP used during both computer penetrations. This is another layer of "no-touch" invisible physical torture and psyops terrorism. A complaint was filed with Oregon Attorney General, Hardy Myers.

Bush-Cheney administration protects their ally Osama bin Laden

On August 16, 2008, a source close to U.S. Special Forces notified me that a military team had recently tracked Osama bin Laden to a location where he and others were clearly identified and while preparing to neutralize their targets, a military team leader received a telephone call with orders from the Bush-Cheney administration "not to kill" Osama bin Laden and to withdraw from the area. This same scenario occurred on September 11, 2001 when George W. Bush ordered the FBI to escort the Bin Laden family to the airport without being questioned. When the U.S. military service member communicated with his command about combat pay and other matters related to the Osama bin Laden mission, he discovered the U.S. Pentagon had classified the operation as a blackops project. The U.S. service member and his team were told by their military command that no combat pay was forthcoming since the operation was classified and therefore they were never there. Under protective conditions my source could be willing to testify before the American people and the U.S. Congress on C-SPAN.

Seems reminiscent and in league with the false testimony and perjury offered by the arrogant Condoleezza Rice to the U.S. Congress during the 911 hearings stated when she stated that "no joint taskforce offices existed between the FBI and CIA before September 11, 2001." That statement was a complete lie and will remain so unless the CIA has rewritten or destroyed the historical evidence. Certainly there is at least one FBI Special Agent who would testify that joint operational offices existed between the FBI and CIA since the early 1990s. That information was conveyed to me during my assistance with the hunt for Eric Rudolf.

The future of my life depends on U.S. Congressional support; the right of legal redress against culpable U.S. Government entities with the national security shielding removed; the awarding of my Social Security Disability Benefits currently awaiting a ruling in the Federal Civil Court, WA; the sanitization and conversion of my Social Security work quarters and University Records; the sealing or removal of my fingerprint records from the FBI databases and the law enforcement academies from which I graduated; a university initiative on humanitarian grounds to afford the completion of my journalism and teaching degrees; the representation of a literary agent to broker books and a film documentary contract with publisher and film producers; special considerations for employment respecting my protective person's status; and retroprosity granted my protective person's status by the United Nations High Commissioner for Refugees and asylum from the Government of Canada.

Every second of everyday I am faced with lethal deportation and virtual extraordinary rendition back to certain death with the commingling of my allegedly federally sealed identities and the outing of my covert status under the Bush-Cheney administration.
