Press Statement

Non-Criminal Federal Witness: No. 7001, terrorized, tortured and passively sanctioned for assassination by the culpable agents and agencies of the U.S. Government under the Bush-Cheney administration. Actively being subjected to warrantless wiretapping through T-Mobile, Inc. that was leaked classified government information and Comcast, Inc. Requesting a Congressional investigation and contact with the BBC in Canada to discuss the production of the Black File 7001 documentary, before November 2008.

Without those of you who still love America and human rights in the U.S. Congress, the news media and entertainment industry contacting me to offer assistance, my life will remain in danger of being assassinated before I am able to share my firsthand true story titled Black File 7001. Unless I am assisted in a manner that removes national security restrictions under Title 18 of the United States Code, the law prevents me from publishing the full names and locations of blacksites and the known culpable agent and agents who have subjected me, my family and 1,080 other Non-Criminal Federal Witnesses to psyops terrorism and CIA "no-touch" invisible physical torture since 1970. In 1999, I successfully completed a five year long undercover assignment with the FBI that never afforded one day off. The research that installed that group-one investigation and later produced a new federal law was sourced entirely by my academic prospectus involving an investigative journalism project into subversive subcultures; I am a gang and clandestine electronic surveillance specialist. With an inactive law enforcement background and no FBI Special Agents available with my skill sets at the time, I voluntarily withdrew from a fulltime university environment and a bright future in journalism, teaching and law to perform covert national service. Upon that successful completion and eight years ago under this criminally sociopathic administration, I entered the misnomer title of the Federal Witness Protection Program and as Non-Criminal Federal Witness, No.: 7001 became one of the other 1,080 unknowing human test subjects and part of a laboratory control sample for the applied tactics of psyops terrorism and CIA "no-touch" invisible physical torture techniques targeted against an unseen minority group within the U.S. civilian population. The WitSec is a shrouded federal program shielded from public scrutiny by duplicitous use of national security protocols to continue the genocidal experiments began in the Auschwitz-Birkenau concentration camps and further developed in America by imported Nazi SS war criminals during the CIA Mk-ULTRA black projects in brainwashing. These rabid vermin conducting this operation are sired from the same lineage of traitors and fascists who continue their global crimes against the American people and the citizens of the free world.

John McCain runs from speaking about his POW days with the NVC, because his "war hero" persona is false. This is the reason why McCain while backed-up by Republican shill John Kerry had his government records classified and sealed forever from public examination. There are those who know that John McCain gave aid and comfort to the enemy without being tortured, produced 38 propaganda tapes that denounced the United States of America as an empire of war criminals [might have been the most honest statement McCain has ever made when referring to the

Culpable federal agents through the commission of actionable offences in political retribution have made it impossible for Bah to find employment after being disabled during two trauma accidents caused by or in the service of the U.S. Government. These same federal agents remain shielded from criminal and civil prosecution under the duplicitous use of Title 18 of the United States Code and National Security Protocols. The agents of the U.S. Government have both deliberately and negligently outed Lee Vin Bah's active covert status to serve as a passive sanction for his assassination through the creation of a mortal threat environment. These attacks intensified when Bah was a cancer patient in 2004. Both John F. Clark, Director U.S. Marshals Service and Sylvester Jones Assistant Director, Witness Security & Prisoner Operations have lied under oath before the U.S. Congress concerning the deaths of federal witnesses. Within the Federal Witness Protection Program [a perversion of language], since 1970, 1,080 non-criminal federal witnesses within this torture experiment that was sired by a tentacle of the CIA's MK-ULTRA mind control program, have become the unknowing test subjects and laboratory control sample for the applied methods of psyops terrorism and invisible physical torture techniques on an unseen minority within the U.S. civilian population. Lee Vin Bah will never forgive or forget that the government he once served has destroyed his life and family and while remaining in mortal danger is actively seeking asylum as a refugee under a protected person's status from the Government of Canada.

Republican overthrow] and most treasonously provided classified flight path information to the NVC, which allowed their repositioning of anti-aircraft weapons to shoot down and murder our U.S. pilots on their return flights home. McCain changed the rules affecting military commanders on the ground to prevent them from staging an immediate rescue when U.S. POWs and MIAs were sighted. Today, military commanders are required to notify the Pentagon and await instructions for a minimum of two days, which removes any likelihood of rescue. My full support is offered Senator Barack Obama and I pray that he will telephonically contact me at some point in the near future to discuss Black File 7001. Possibly your other Congressional members can inquire why Senator, Ron Wyden; Congressman, David Wu; Oregon Attorney General, Hardy Myers or Oregon Governor, Ted Kulongoski have not personally responded to multiple notice. Those who know me by my legal name in the FBI, CIA, U.S. Secret Service, U.S. Navy UDT/SEAL, and others would tell you that I am well liked and highly proficient within my skill sets; I am passionate about this mission and equally approachable to communicate.

Earlier this week a source close to the U.S. Special Forces reported that Osama bin Laden was identified with other hostiles. The team leader was prepared to neutralize the group and received a telephonic communication from the Pentagon "do not kill Osama bin Laden and withdraw your team from the region." The team was short-changed on payday and inquired about their combat pay, only to be told the mission had been classified and therefore they were never in the Pakistani region. It is not the FBI who is culpable even though I am certain that agency has been manipulated by those who are. My life has been repeatedly threatened through direct and veiled means, which often makes unlawful use of a communication facility. Numerous tactics of psyops terrorism and CIA "no-touch" invisible physical torture have been used against me and members of my family by the culpable agents and agencies

of the U.S. Government under the Bush-Cheney administration. There is evidence of electromagnetic pulse [EMP], microwave and radio frequency weapons technologies having been used against me. Sensory disorientation tactics have been used during repeated telephone calls placed to my home and mobile numbers around the clock for over two months. Hostile combative telephonic and Skype communications were placed to me by persons speaking in Arabic or other languages as a method of illegal reverse targeting under FISA. Since January 20, 2006 there exists clear physical evidence of warrantless wiretapping with classified federally sealed government information having been leaked to T-Mobile, Inc. in violation of national security protocols. On Christmas Eve 2004, my computer was penetrated for the electronic theft of my intellectual property in an anti-Semitic psyops message that removed or destroyed my documents after my refusal to the threat of the U.S. Government's "invention" of a criminal charge if I published my book. On Monday, July 25, 2008, I received a telephonic death threat on my T-Mobile cellphone through a text message. On Friday, August 20, 2008, I received a telephonic death threat on my T-Mobile cellphone through a text message.

On Wednesday, August 13, 2008, following my press release concerning the alleged suicide of Dr. Bruce L. Ivans and the faked suicide/murder of Dr. Frank Olson from the same secret laboratory at Fort Detrick, MD, I "immediately" received a call from a Maryland telephone number that left no message [301-237-8182]. My elderly mother's home was subjected to a daylight robbery.

On Thursday, August 14, 2008, for the second occasion and the first event on my new personal computer, I discovered that the machine had been electronically penetrated the night before for the theft of my intellectual property and the removal of the single research file containing all of the MLA Citations for the Black File 7001 book draft. The file was saved within my browser with approximately ten others and the Black Project: MLA Citations file was the only one removed. It is not recoverable and demonstrates the Bush-Cheney administration's further validation and endorsement of the Black File 7001 and their clandestine use of American citizens as human test subjects for torture and terrorism.

Additionally my computer's Outlook program was corrupted and a power surge from an electronic pulse was detected that destroyed one of my external hard drives.

There are three offices with "three" computers in our home. On Thursday, August 21, 2008, an in-line detection device clearly shows that a "fourth" computer or cloned system like that produced by DCSNet, for Digital Collection System Network or that of another surveillance device has been installed to illegally monitor our private business transactions following a complaint filed against Comcast, Inc. for a violation of the Oregon Unlawful Trade Practice Act. The illegal reverse targeting under FISA continues, warrantless wiretapping, data mining, torture, and terrorism. Beyond the oblivious violation of human and civil rights by the U.S. Government, I am prevented from practicing my eclectic religious faith by the government's actionable offenses.
