LET IT BE FURTHER KNOWN that you are engaged in an ILLEGAL TRESPASS on the sovereign territory of the Squamish Nation, according to a duly filed EVICTION ORDER issued against the United Church of Canada on March 4, 2008 by the sovereign Siem of the Squamish people, Chief Kiapilano. (*B.C. Supreme Court Docket No. S036483*)

ACCORDINGLY, under the law you are liable for immediate arrest and the seizure of your assets and property, according to this EVICTION ORDER and the lawful verdict of The International Common Law Court of Justice that convicted the United Church of Crimes against Humanity. (*February 25, 2013, Case docket 02252013-001A, ICLCJ Brussels*)

YOU ARE THEREFORE ORDERED to immediately vacate your church properties in the Lower Mainland, and to cease and desist from associating with, funding or operating under the direction of the United Church of Canada, on pain of arrest, imprisonment and the public seizure of your church properties.

Issued on this Thirtieth Day of May in the year 2019 under the authority of The International Common Law Court of Justice and hereditary Siem Kiapilano and the Land Law jurisdiction of the Squamish Nation.

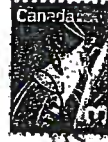
